JOINT MOTION TO ADMIT EVIDENCE AND NOTICE OF APPROVAL

COMES NOW, the Staff of the Public Utility Commission of Texas (Staff), on behalf of itself and Union Grove Water Supply Corporation (Union Grove or Applicant) (together the "Parties), and files this Joint Motion to Admit Evidence, and Notice of Approval. In support thereof, the Parties show the following:

BACKGROUND

On May 23, 2017, Union Grove filed with the Commission an application to amend its water Certificate of Convenience and Necessity (CCN) No. 10514 in Upshur County, Texas. Staff filed a final recommendation of approval on February 13, 2018. Pursuant to Commission Administrative Law Judge Order No. 6, the Parties timely file this joint motion to admit evidence and notice of approval.

JOINT MOTION TO ADMIT EVIDENCE

The Parties move to admit the following evidence into the record of this proceeding:

- 1. Union Grove application, filed on May 23, 2017, as to add three new areas of service that total approximately 2,212 acres and include 35 current customers and seeks to be dually-certificated with the City of East Mountain in a portion of the new service area;
- 2. The affidavits and proof of notice, filed on October 30, 2017;
- 3. The consent forms to the final map and certificates, filed on January 31, 2017; and

4. Commission Staff's Final Recommendation that the Application be approved, filed on February 13, 2018.

JOINT PROPOSED NOTICE OF APPROVAL

Staff and Union Grove have agreed on the attached Joint Proposed Notice of Approval to grant Union Grove's Application to amend water CCN No. 10514 in Upshur County, Texas. Also attached are the final map and certificates that were included in Staff's final recommendation.

The Parties respectfully request that the Commission grant the Motion to Admit Evidence, and adopt the attached Joint Proposed Notice of Approval.

JOINT PROPOSED NOTICE OF APPROVAL

This Joint Proposed Notice of Approval addresses the application (Application) of Union Grove Water Supply Corporation (Union Grove) for to amend its water Certificate of Convenience and Necessity (CCN) and to obtain dual certification with a portion of the City of East Mountain in Upshur County, Texas. The Public Utility Commission (Commission) Staff recommended approval of this Application. The Application is approved. The Commission adopts the following findings of fact and conclusions of law:

I. FINDINGS OF FACT

Procedural History and Background

- On May 23, 2017, Union Grove filed an Application to amend its water CCN No. 10514 and for dual certification in certain areas of Upshur County, Texas.
- 2. On May 26, 2017, Order No. 1 was issued, requiring comments on administrative completeness and notice, requesting procedural schedule, and addressing other procedural matters.
- 3. On September 29, 2016, the Administrative Law Judge ("ALJ") issued Order No. 2 deeming the application administratively complete.
- 4. On October 3, 2017, Order No. 4 was issued, finding that the Application was administratively complete and required Union Grove to provide notice.
- 5. On November 17, 2017, Order No. 5 was issued, finding notice sufficient.
- 6. On January 31, 2018, Union Grove and the city of East Mountain filed consent forms agreeing with the certificates and map.
- 7. On December 5, 2017, Commission Staff filed its Final Recommendation, which recommended that the application be approved.

8. On _____, Order No. _____ was issued, admitting evidence into the record of this proceeding.

Notice

- 9. On May 26, 2017, the Commission issued notice of Union Grove's application.
- 10. On October 3, 2017, Union Grove mailed notice of the Application to current customers, neighboring utilities, and affected parties.
- 11. An affidavit that attests to this notice was dated October 24, 2017.
- 12. Notice of the application was published in The Magnolia Potpourri on October 5, 2017 and October 12, 2017.
- 13. On October 24, 2017, affidavits of notice and publication were filed.
- 14. Evidentiary Record

15. Informal Disposition

- 16. More than 15 days have passed since completion of the notice provided in this docket.
- 17. Union Grove and Commission Staff are the only parties to this proceeding.
- 18. No requests for a hearing have been filed and no issues of fact or law are disputed by the parties. Therefore, no hearing is necessary.

II. CONCLUSIONS OF LAW

- 1. The Commission has jurisdiction and authority over this docket pursuant to Tex. Water Code §§ 13.041, 13.241, and 13.246 (TWC) and 16 Tex. Admin. Code §§ 24.102, 24.106, and 24.107 (TAC).
- 2. Union Grove is a retail public utility as defined in TWC § 13.002(19) and 16 TAC § 24.3(59).
- 3. Union Grove provided notice of the Application in compliance with TWC § 13.246 and 16 TAC § 24.106.
- 4. The Application was processed in accordance with the TWC and Commission rules.
- 5. After considering the factors in TWC § 13.246(c), Union Grove is entitled to approval of the application, having demonstrated adequate financial, managerial and technical capability for providing continuous and adequate service to the request area and its current service area as required by TWC § 13.241.


- 6. Union Grove has demonstrated that the Application meets the requirements set forth in TWC §§ 13.241 and 13.246 and 16 TAC §§ 24.101 and 24.102 to be granted a CCN.
- 7. Approval of the Application is necessary for the service, accommodation, convenience, or safety of the public, as required under TWC § 13.246(b) and 16 TAC § 24.102(c).
- 8. Pursuant to TWC § 13.257(r) and 16 TAC § 24.106(e), Union Grove is required to record a certified copy of the approved CCN and map, along with a boundary description of the service area in the real property records of each county in which the service area or a portion of the service area is located, and submit to the Commission evidence of the recording.
- 9. The requirements for informal disposition pursuant to 16 TAC § 22.35 have been met in this proceeding.

III. ORDERING PARAGRAPHS

- 1. The Application for a water CCN amendment in Upshur County, Texas is approved.
- 2. Union Grove's water CCN No. 10514 is amended, consistent with this Notice.
- 3. Union Grove shall serve every customer and applicant for service within the areas certified under its water CCN, and such service shall be continuous and adequate.
- 4. Union Grove shall comply with the recording requirements in TWC § 13.257(r) for the area in Upshur County affected by the application and submit to the Commission evidence of the recording no later than 31 days after receipt of this Notice.
- 5. All other motions, requests for entry of specific findings of fact and conclusions of law, and any other requests for general or specific relief, if not expressly granted herein, are denied.
