Ryan Long I Subdivision:

The area subject to this transaction is located approximately $\underline{4}$ miles <u>south</u> of downtown <u>Pearland</u>, Texas, and is generally bounded on the north by <u>Carrie Ln</u>; on the east by <u>Frazier</u> <u>Ln</u>; on the south by <u>650' south of Carrie Ln</u>; and on the west by <u>Bounds Dr</u>. in <u>Brazoria</u> County. The total area being requested includes approximately <u>32</u> acres and serves <u>15</u> current customers.

Coronado Country Subdivision:

The area subject to this transaction is located approximately $\underline{4}$ miles <u>west/southwest</u> of downtown <u>Pearland</u>, Texas, and is generally bounded on the north by <u>Magnolia Rd</u>; on the east by <u>Ethel St</u>; on the south by <u>175' south of Treasure Ln</u>; and on the west by <u>Chocolate Bayou Rd</u> in <u>Brazoria</u> County. The total area being requested includes approximately <u>19</u> acres and serves <u>39</u> current customers.






