#### **DEFINITIONS**

- A. "City," "the Company" or "you" refers to the City of Austin and any person acting or purporting to act on their behalf, including without limitation, attorneys, agents, advisors, investigators, representatives, employees or other persons.
- B. "Document" includes any written, recorded, or graphic matter, however produced or reproduced, including but not limited to correspondence, telegrams, contracts, agreements, notes in any form, memoranda, diaries, voice recording tapes, microfilms, pictures, computer media, work papers, calendars, minutes of meetings or other writings or graphic matter, including copies containing marginal notes or variations of any of the foregoing, now or previously in your possession. In the event any documents requested by this Request for Information have been transferred beyond the Company's control, describe the circumstances under which the document was destroyed or transferred and provide an exact citation to the subject document. ## COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION TO CITY OF AUSTIN (CITY) QUESTION NOS. STAFF 1-1 THROUGH STAFF 1-3

- Staff 1-1 Provide facility maps of the proposed CCN service areas that show distribution and transmission lines, as well as any interconnects. Ensure that the maps are large enough to show the lines clearly and identifies which public water system (PWS) is associated with the facility maps.
- Staff 1-2 Provide proof that either a preliminary engineering report or plans and specifications for the first phase of the system have been submitted to the TCEQ.
- Staff 1-3 The agreement with Sunfield MUD No. 2 mentions a "Water Service Plan". Provide this plan for review.
