**COMMISSION STAFF'S FIFTH SUPPLEMENTAL RECOMMENDATION ON
ADMINISTRATIVE COMPLETENESS**

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this response to Order No. 6, Commission Staff's Fifth Supplemental Recommendation on Administrative Completeness. Staff recommends that the application be found administratively complete. In support thereof, Staff shows the following:

I. BACKGROUND

On May 31, 2017, the City of Austin (Applicant) filed an application to amend its water certificate of convenience and necessity (CCN) No. 11322 and Sunfield MUD No. 4's CCN No. 13116 in Hays County. Sunfield MUD No. 4 is in a portion of CCN No. 13116 and seeks to be decertified and transferred to the City of Austin's CCN No. 11322. The total area being requested includes approximately 575 acres and includes 0 current customers.

On February 22, 2018, the Administrative Law Judge (ALJ) issued Order No. 6, which required Staff to file a supplemental recommendation on administrative completeness by March 15, 2018. On March 13, 2018, the ALJ granted the Applicant's Request for Extension and extended Staff's deadline to file a supplemental recommendation on administrative completeness to March 23, 2018. Therefore, this pleading is timely filed.

II. APPLICATION SUFFICIENCY RECOMMENDATION

Staff has reviewed the Application filed on May 31, 2017, and the Applicant's supplemental filings filed on September 20, 2017, September 22, 2017, November 11, 2017, February 15, 2018, March 9, 2018, and March 15, 2018, as supported by the attached memorandum of Debbie Reyes

Tamayo of the Water Utility Regulation Division, Staff finds the application sufficient and recommends that the application be found administratively complete.

III. ISSUANCE OF NOTICE

Staff recommends that the Applicant be ordered to provide notice to: (1) any districts, utilities, and cities within two miles of the proposed area; (2) the county judge of each county and each groundwater conservation district that is wholly or partly included in the proposed area to be certified; (3) each city with an extraterritorial jurisdiction (ETJ) that is wholly or partly included in the proposed area to be certified; and (4) landowners who own a tract of land that is at least 25 acres and is wholly or partly located in the proposed area to be certified.

The Applicant should also issue notice to the entities listed in the attached Staff memorandum. Proposed notice is provided herein for the Applicant's use as Attachment A. After sending such notice, the Applicant should file a copy of the actual notice sent, including a copy of the map, a list of the entities to whom notice was sent, and a signed affidavit affirming that the notices were sent. A blank affidavit for such purposes is attached to this pleading as Attachment B.

The Applicant shall also publish the notice in a newspaper with general circulation in Hays and Travis counties. The notice must be published once each week for two consecutive weeks beginning with the week after the notice is received from the Commission. Proof of publication in the form of a publisher's affidavit shall be submitted to the Commission within 30 days of the last publication date. The affidavit shall state with specificity each county in which the newspaper is of general circulation. A blank affidavit for such purposes is attached to this pleading as Attachment C.

IV. PROPOSED PROCEDURAL SCHEDULE

In accordance with Staff's administrative completeness recommendation, Staff proposes the following procedural schedule:

Deadline for Applicant to file with the Commission signed affidavits that the notice was given along with a copy of the notice sent to the affected parties and published in a newspaper of general circulation.	May 7, 2018

Deadline for Staff to file a recommendation on sufficiency of notice.	Within 10 days of Applicant filing proof of completed notice with the Commission
Deadline to intervene.	30 days after notice is issued

V. CONCLUSION



Re: **Docket No. 47229:** *Application of City of Austin to Amend a Water Certificate of Convenience and Necessity and to Decertify Sunfield Municipal Utility District No. 4 in Hays County*

On May 31, 2017, the City of Austin (City or Applicant) filed with the Public Utility Commission of Texas (Commission) an application to amend their water Certificate of Convenience and Necessity (CCN) No. 11322 and to decertify a portion of Sunfield MUD 4's CCN No. 13116, in Hays and Travis Counties pursuant to Texas Water Code (TWC) §§ 13.242 to 13.250 and 16 Tex. Admin Code (TAC) §§ 24.101 to 24.107.

A Staff review of the additional information filed by the Applicant on March 9, 2018, found that it is sufficient in the required application and mapping information. Therefore, Staff recommends that the application be deemed sufficient for filing and found administratively complete. Staff further recommends the Applicant be ordered to do the following:

- 1) Provide correct notice of the application to the following:
 - a) any districts, utilities, and cities within two (2) miles of the requested service area;
 - b) the county judge of each county and each groundwater conservation district that is wholly or partly included in the requested area to be certified;
 - c) each city with an extraterritorial jurisdiction (ETJ) that is wholly or partly included in the requested area; and
 - d) affected customers, and
 - e) publish notice once each week for two (2) consecutive weeks in a newspaper of general circulation in Hays and Travis Counties.
- 2) Provide correct notice of the application to the following:
 - Aqua Texas Inc. (CCN No. 11157)
 - City of Buda (CCN No. 11953)
 - Creedmoor Maha WSC (CCN No. 11029)
 - Goforth SUD (CCN No. 11356)
 - Lower Colorado River Authority (CCN No. 11670)
 - Mystic Oak Water Supply Inc. (CCN No. 12409)
 - Sunfield MUD 4 (CCN No. 13116)
 - Barton Springs-Edwards Aquifer Conservation District
 - Cascades MUD 1
 - Guadalupe-Blanco River Authority
 - South Buda WCID 1
 - Sunfield MUD 1

- Sunfield MUD 2
 - Sunfield MUD 3
 - Travis-Creedmoor MUD
 - City of Buda
 - City of Creedmoor

- 3) Provide an accurate map delineating the requested service area with each individual notice to neighboring utilities, other affected parties, and customers. Information related to districts including addresses can be obtained by the Applicant from the TCEQ web site located at <http://www14.tceq.texas.gov/iwud/>.
- 4) Within 30 days of the date of the notice, file in the docket a map and copy of notice along with an affidavit specifying every person and entity to whom notice was provided, the date that the notice was provided, and the publisher's affidavit for proof of newspaper publication. It is recommended that the Applicant use the attached notices and affidavits to meet these requirements.
