JOINT MOTION TO ADMIT EVIDENCE AND PROPOSED NOTICE OF APPROVAL

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), The City of Austin (Austin) and Sunfield Municipal Utility District No.4 (Sunfield), (collectively, Applicants) (together, the Parties), and files this Joint Motion to Admit Evidence and Proposed Notice of Approval. In support thereof, the Parties show the following:

I. BACKGROUND

On May 31, 2017, the City of Austin filed an application to amend its water certificate of convenience and necessity (CCN) No. 11322 and decertify a portion of Sunfield No. 13116 in Hays and Travis Counties. Sunfield is in a portion of CCN No. 13116 and seeks to be decertified and transferred to Austin's CCN No. 11322. The total area being requested includes approximately 575 acres and includes 0 current customers.

On May 15, 2018, the administrative law judge (ALJ) issued Order No. 9, which required the Parties to file a joint proposed notice of approval by August 17, 2018. This pleading is therefore timely filed.

II. JOINT MOTION TO ADMIT EVIDENCE

The parties move to admit the following into the record of evidence of this proceeding:

III. JOINT PROPOSED NOTICE OF APPROVAL

The attached Joint Proposed Notice of Approval would amend Austin's CCN No. 11322 and decertify a portion of Sunfield's CCN No. 13116 in Hays and Travis Counties.
