**ORDER NO. 3
 DEEMING APPLICATION ADMINISTRATIVELY COMPLETE,
 ADDRESSING NOTICE, ESTABLISHING PROCEDURAL SCHEDULE;
 AND RESTYLING DOCKET**

This Order addresses Commission Staff's September 8, 2017, recommendation on the administrative completeness of the application. Commission Staff recommended the application be deemed administratively complete and that the applicant be required to provide notice consistent with the memorandum of Andrew Novak of the Commission's Water Utility Regulation Division. Commission Staff recommended that the applicant be required to submit signed affidavits indicating that notice was given, along with a copy of the actual notices issued, within 30 days of the date of notice and last publication date. Commission Staff proposed a procedural schedule for continued processing of this application.

Commission Staff noted that the August 3, 2017, filing of Hickory Creek Special Utility District removes the overlap between its certificate of convenience and necessity and the City of Wolfe City's CCN, and that Hickory Creek SUD is no longer seeking dual certification with the City of Wolfe City at this time. The maps provided in the supplemental filing also indicate that the areas Hickory Creek SUD is seeking to add are located entirely in Hunt and Fannin Counties. Commission Staff recommended the style of this docket be amended to read: *Application of Hickory Creek Special Utility District to Amend a Water Certificate of Convenience and Necessity in Hunt and Fannin Counties.*

Consistent with Commission Staff's recommendation, this application is deemed sufficient and administratively complete. Hickory Creek SUD shall provide notice of this application consistent with Commission Staff's September 8, 2017, recommendation and use the forms provided in the recommendation. Additionally, the style of this proceeding shall be changed to read: *Application of Hickory Creek Special Utility District to Amend a Water Certificate of*

Convenience and Necessity in Hunt and Fannin Counties. All future filings should reflect the revised style. Commission Staff's proposed procedural schedule is adopted as follows:

Event	Date
Deadline for the applicant to file with the Commission signed affidavits that the notice was given along with a copy of the notice sent to the affected parties and published in a newspaper of general circulation	October 23, 2017
Deadline for Commission Staff to file a recommendation on sufficiency of notice	Within 10 working days of the applicant filing proof of completed notice with the Commission
Deadline to intervene	30 days after notice is issued
