## ORDER NO. 3

**DEEMING APPLICATION ADMINISTRATIVELY COMPLETE,  
ADDRESSING NOTICE, ESTABLISHING PROCEDURAL SCHEDULE;  
AND RESTYLING DOCKET**

This Order addresses Commission Staff's August 23, 2017, recommendation on the administrative completeness of the application. Commission Staff recommended the application be deemed administratively complete and that the applicant be required to provide notice consistent with the memorandum of Debbie Reyes Tamayo of the Commission's Water Utility Regulation Division. Commission Staff recommended that the applicant be required to submit signed affidavits indicating that notice was given, along with a copy of the actual notices issued, within 30 days of the date of notice and last publication date. Commission Staff proposed a procedural schedule for continued processing of this application.

Commission Staff noted that the application listed both Henderson and Van Zandt Counties as areas for which service is proposed; however, after further analysis of the application and maps, Commission Staff found that the service area is solely within Van Zandt County. Commission Staff recommended the style of this docket be amended to read: *Application of RPM Water Supply Corporation to Amend a Water Certificate of Convenience and Necessity in Van Zandt County*.

Consistent with Commission Staff's recommendation, this application is deemed sufficient and administratively complete. RPM Water Supply Corporation shall provide notice of this application consistent with Commission Staff's August 23, 2017, recommendation and use the forms provided in the recommendation. Additionally, the style of this proceeding shall be changed to read: *Application of RPM Water Supply Corporation to Amend a Water Certificate of Convenience and Necessity in Van Zandt County*. All future filings should reflect the revised style. Commission Staff's proposed procedural schedule is adopted as follows:

Deadline for Commission Staff to file a recommendation on sufficiency of notice	Within 10 working days of the applicant filing proof of completed notice with the Commission
Deadline to intervene	30 days after notice is issued
