

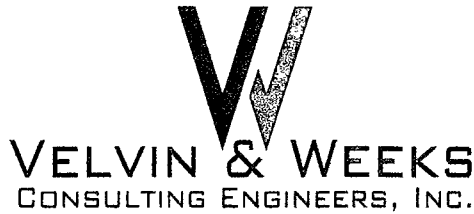

The requested area is located approximately 2.6 miles northeast of downtown Edom and is generally bounded on the north by SH 64; on the east by CR 4929; on the south by CR 4810; and on the west by CR 4807.

The total requested area includes approximately 22 acres and 11 current customers

The requested area overlaps the boundaries of the following districts. If the following districts do not request a public hearing, the Commission shall determine that the districts are consenting to the RPM WSC's request to provide retail water utility service in the requested area.

- Angelina & Neches River Authority
- Van Zandt County Waste Disposal District

You may request a public hearing. A request for a public hearing must be in writing and include: (1) your name, mailing address, and daytime telephone number; (2) the Utility's name, docket number or another recognizable reference to this application; (3) the statement, "I/we request a public hearing"; (4) a brief description of how you or the persons you represent, would be adversely affected by the granting of the application for a CCN; and (5) your proposed adjustment to the application which would satisfy your concerns and cause you to withdraw your request for a hearing.

within thirty (30) days from the date of this publication or notice. A public hearing will be held only if a legally sufficient hearing request is received or if the Commission on its own motion requests a hearing. Only those individuals who submit a written request will receive notice if a hearing is scheduled.

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.

A landowner with a tract of land at least 25 acres or more, that is partially or wholly located within the requested area, may file a written request with the Commission to be excluded from the requested area ("opt out") within (30) days from the date that notice was provided by the Utility. All opt out requests must include a large-scale map and a metes and bounds description of the landowner's tract of land.

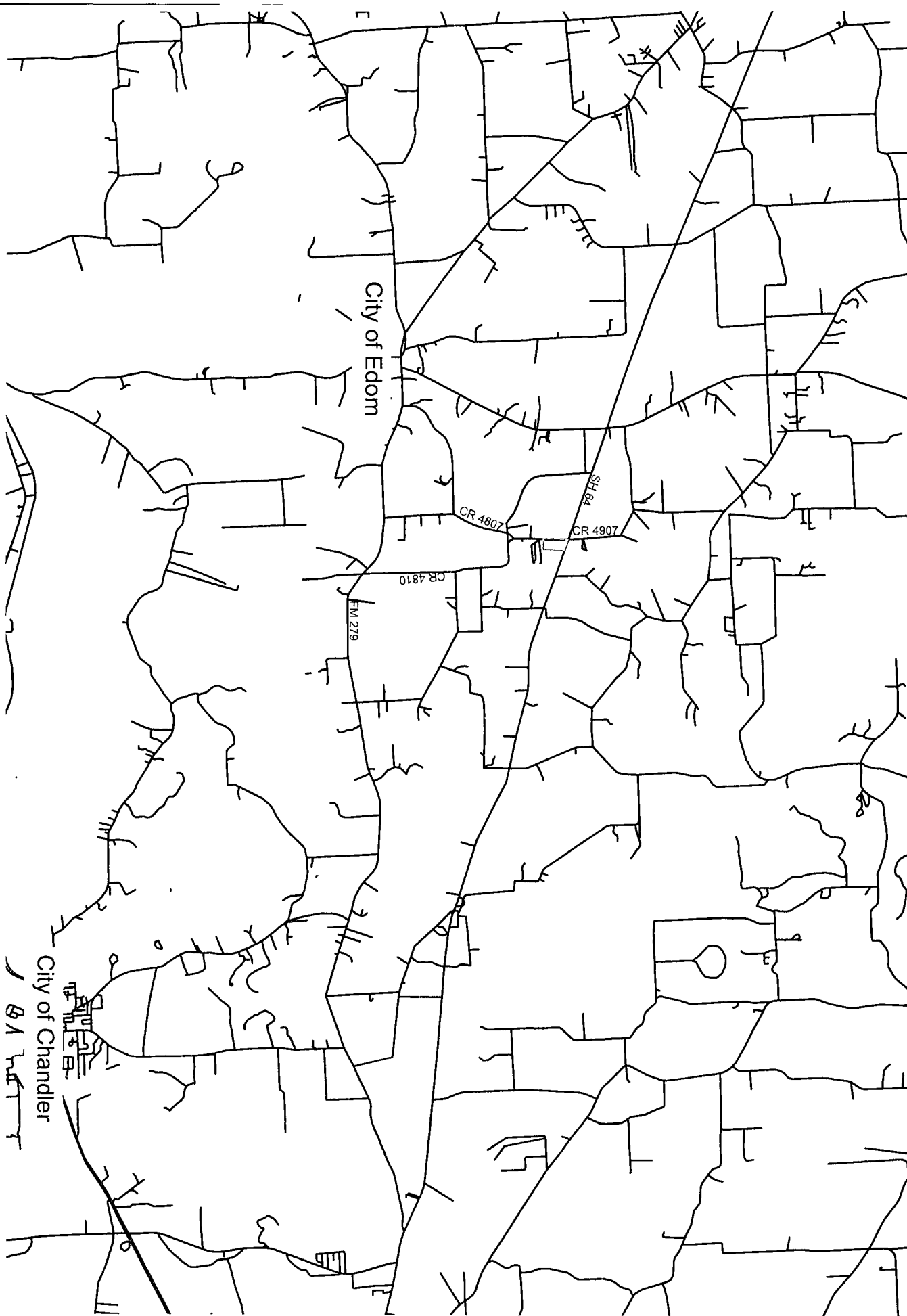

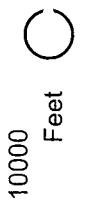
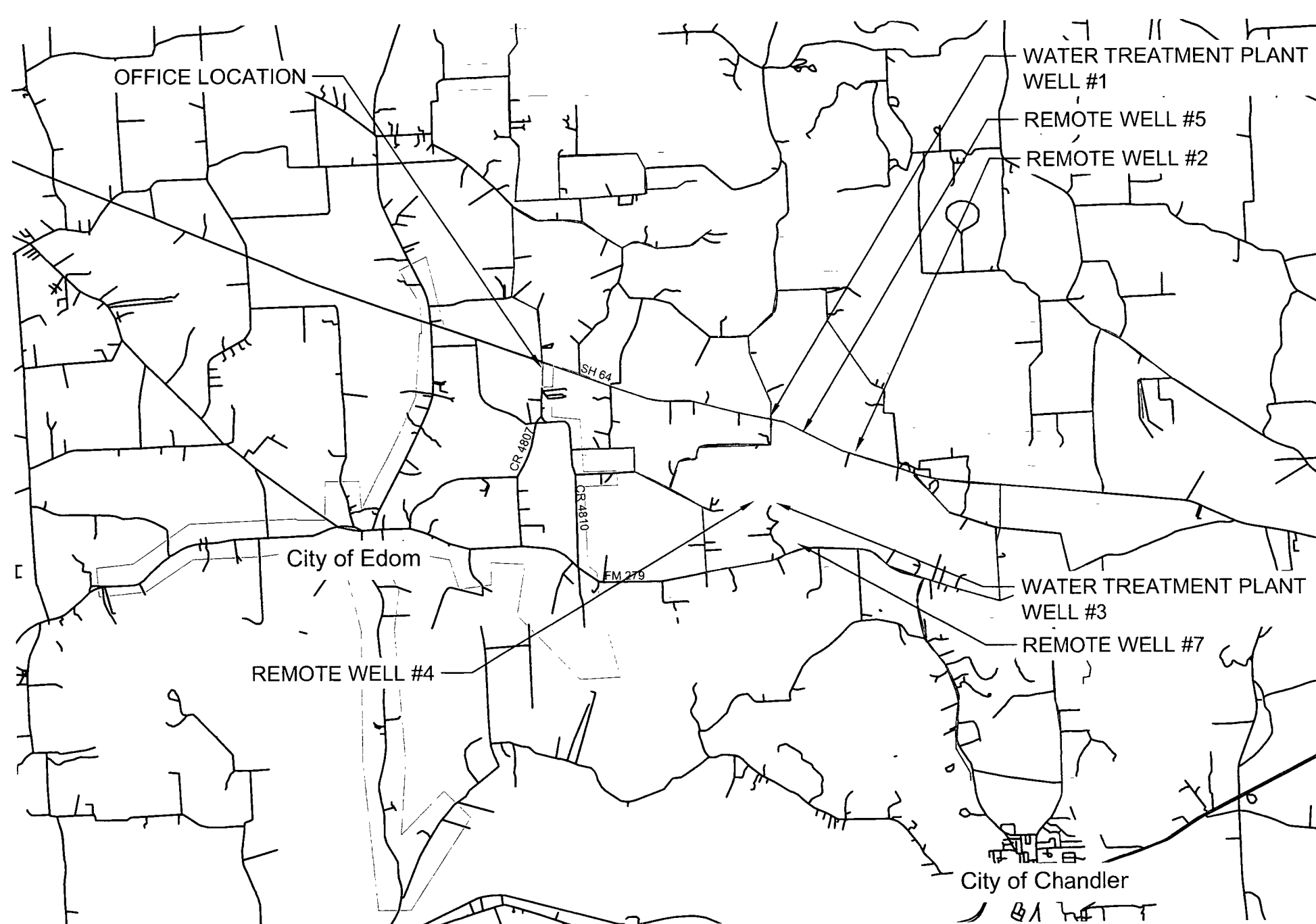

Certification Area

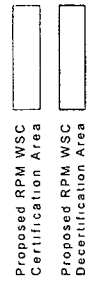
