- 1-2 Admit or deny that you do not dispute that the size of the lot at 19818 Black Cherry Bend Ct. is 7050 square feet.
- 1-3 If you deny the previous request, state the basis for your denial and indicate the size of the lot at 19818 Black Cherry Bend Ct, in square feet, that you believe is accurate.
- 1-4 Was there a sprinkler system at 19818 Black Cherry Bend Ct. during the time that you resided there? If so, identify the sprinkler system, the number of zones, the number of sprinkler heads, the normal duration of irrigation for each zone and the frequency of irrigation (days per month and number of times per day).
- 1-5 What time of day do you normally use your irrigation system at 32811 Sawgrass Ct to water your lawn? From when to when?
- 1-6 Does your irrigation system at 32811 Sawgrass Ct have a rain sensing device?
