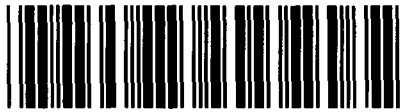

Reply to West Wise SUD's Statement of Review


