Dear Texas PUC:

On July 7<sup>th</sup>, 2017 the PUC Staff recommends additional information for Docket Number 47289 filed by Hubert-Watson Water Supply, Inc (HW).

From PUC notice 47289-4 paragraph II the items HW is directed to provide are listed as follows:

1. Indicate whether any money was transferred in the redemption of the Betty Hubert Wise Trust shares -- short answer No
2. File a copy of the purchase agreement for the shares to be purchased by Randal Boenigk -- short answer shares are to be gifted with no compensation
3. Identify the owner of the \$1,200 in common stock listed on Hubert-Watson's books -- short answer currently 50% each James Garland Watson and Judith Watson Perkins

**Any Money Transferred in Redemption of the Betty Hubert Wise Trust?**

There was no money transferred between the parties in the redemption of the BHW Trust. In respondent's initial filing on Document Page 4 should be found a wordy description of the process as well as respondent's initial attempt at stating the that no monies were involved.

Mr. Randal Boenigk is to be gifted shares equally from each of the current 50% owners such that the three owners will eventually have equal 1/3 ownership of HW. Copies of the draft gift agreements are attached.






