**ORDER NO. 6
REQUIRING FILING**

In Order No. 4,¹ Chateau Woods Municipal Utility District was ordered to provide, proof of direct notice to neighboring utilities, landowners, and cities. Chateau Woods submitted proof of published notice on November 17, 2017, but an affidavit addressing direct, mailed notice is still lacking. In order to continue processing the application, proof of direct notice is required.

Therefore, on or before February 14, 2018, Chateau Woods shall submit proof of direct notice consistent with Commission Staff's previous instructions. A copy of the affidavit form required is provided with this Order.

Within ten days of Chateau Woods filing proof of direct notice, Commission Staff shall file a recommendation on the sufficiency of notice.

The parties are advised that the request for hearing by the City of Oak Ridge North remains pending and will be addressed in a separate order.
