**MOTION TO GRANT THE CITY OF OAK RIDGE NORTH'S REQUEST TO**  
**WITHDRAW AS A PARTY**

COMES NOW, Chateau Woods Municipal Utility District ("CWMUD") and files this Motion to Grant the City of Oak Ridge North's ("City") Request to Withdraw as a party in above referenced Docket.

1. On December 5, 2017, the City filed its letter with the Public Utility Commission ("PUC") to request to intervene in CWMUD's pending application to amend its sewer certificate of convenience and necessity ("CCN") in the above referenced docket.

2. On December 14, 2017, the PUC issued Order No. 5 granting the City's request to intervene in the above referenced docket.

3. CWMUD has addressed and resolved the concerns of the City with regard to CWMUD's pending application to amend its sewer CCN in the above referenced docket.

4. Attached to this motion is the City's request to the PUC to withdraw as a party in the above referenced docket. The City is aware and in agreement with this filing to the PUC to withdraw the City's petition.

5. In discussion with the attorney for the City, the City acknowledges that it is aware that CWMUD's amended sewer CCN area includes property within the City's municipal

boundary but not in the City's sewer CCN area. The City's withdrawal is being made with full knowledge of that fact.

6. CWMUD respectfully requests that the PUC accept the City's letter, grant the City's request to withdraw as a party, and dismiss the City as a party to this proceeding.

7. Further, CWMUD respectfully requests that the PUC finalize and approve the application of CWMUD as an uncontested matter and grant the sewer CCN amendment to CWMUD.
