COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON NOTICE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Supplemental Recommendation on Notice in response to Order Nos. 4 and 6 and would show the following:

I. BACKGROUND

On June 19, 2017, Chateau Woods Municipal Utility District (CWMUD) filed an application to amend its sewer Certificate of Convenience and Necessity No. 20937 in Montgomery County. CWMUD filed supplemental information on September 22, 2017. On November 17, 2017, CWMUD filed proof of published notice. On February 22, 2018, and March 2, 2018, CWMUD filed proof of direct mail notice.

On November 21, 2017, Order No. 4 was issued, and on February 2, 2018, Order No. 6 was issued. Both orders established a deadline of ten days from the filing of supplemental proof of notice documentation for Staff to file a recommendation on sufficiency of notice. CWMUD filed supplemental proof of notice documentation on February 22, 2018, and March 2, 2018. Ten days from February 22 is March 4, which is a Sunday. This pleading is therefore timely filed under 16 Texas Administrative Code (TAC) § 22.4(a).

II. NOTICE

Staff has reviewed the proof of notice documentation filed by CWMUD on November 17, 2017, February 22, 2018, and March 2, 2018, and recommends that CWMUD's notice be found sufficient.

On December 5, 2017, the City of Oak Ridge North filed a request to intervene, which was granted by Order No. 5 on December 14, 2017. Oak Ridge North's request to intervene also requested a hearing on CWMUD's application. On March 2, 2018, a letter from Oak Ridge North

was filed withdrawing Oak Ridge North's objections to CWMUD's application. Staff therefore does not recommend that this proceeding be referred to the State Office of Administrative Hearings (SOAH) at this time.

III. PROCEDURAL SCHEDULE

Staff recommends the notice be found sufficient. Staff therefore proposes the following procedural schedule:

Event	Date
Notice completed	November 13, 2017
Deadline for intervention	December 13, 2017 ¹
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable), to Applicant for review and consent	April 23, 2018
Deadline for Applicant to file signed consent forms with the Commission	May 7, 2018
If no hearing is requested, deadline for Staff to file a final recommendation on the Application	May 14, 2018
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law	May 21, 2018

IV. CONCLUSION

For the reasons discussed above, Staff recommends that CWMUD's proof of notice be found sufficient. Staff further recommends that the procedural schedule proposed above be adopted for further processing of this docket and that this docket not be referred to SOAH at this time.


¹ Under 16 TAC § 24.106(a)(3), the intervention deadline is 30 days after the mailing or publication of notice, whichever occurs later. Notice was mailed on November 13, 2017, and published on October 20 and October 27, 2017. Therefore, 30 days after November 13, 2017 is December 13, 2017.


