COMMISSION STAFF'S CORRECTIONS TO THE PROPOSED ORDER

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files these Corrections to the Proposed Order. In support thereof, Staff shows the following:

I. BACKGROUND

On July 19, 2019, the Commission administrative law judge (ALJ) issued a Proposed Order to be considered at the open meeting scheduled for August 8, 2019, and directed the parties to file corrections or exceptions to the Proposed Order on or before August 1, 2019. Therefore, this pleading is timely filed.

II. STAFF'S PROPOSED CORRECTIONS

Staff proposes the following corrections to the Proposed Order:

- Modify current Finding of Fact No. 11 to correct the date.
11. Notice of the application appeared in the July 28, ~~2018~~ 2017 issue of the *Texas Register*.
- Modify the three Findings of Fact immediately following Finding of Fact No. 41 to correct the current numbering. Modify the numbers to the remaining Findings of Fact accordingly.
 - 1- 42. Since the requested area will be serviced via existing water and sewer infrastructure, the issuance of a water and sewer CCN should have no effect on the land.
 - 2- 43. Horseshoe Bay will continue to provide service to the existing customers in the requested area.
 - 3- 44. Horseshoe Bay did not indicate that there would be any expected reduction of costs.

- Modify the Ordering Paragraph immediately following Ordering Paragraph No. 1 to correct the current numbering. Modify the numbers to the remaining Ordering Paragraphs accordingly.
 - ~~1-~~ 2. The Commission grants the certificates attached to this Order.
- Modify Ordering Paragraph No. 2 to clarify the intent of Staff's petition request on March 1, 2018.
 - ~~2-~~ 3. The Commission grants the petition for revocation of a water CCN, by reason of default, and revokes Deerhaven Inc.'s water CCN number 10467.
- Reopen the record to admit into evidence Commission Staff's Recommendation on Administrative Completeness and Petition to Revoke the Certificate of Convenience and Necessity of Deerhaven, Inc. and Notice of Opportunity for Hearing, filed March 1, 2018 (AIS No. 17). In the alternative, remove current Finding of Facts Nos. 54, 55, and 62 since each entry relies on the aforementioned pleading, which has not been admitted into evidence in this proceeding.

III. CONCLUSION

Staff respectfully requests that the Commission adopt the corrections proposed above.
