

# COMMISSION STAFF'S REQUEST TO SUSPEND RATES AND REFER THIS MATTER TO SOAH

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Response to Order No. 3, and would show the following:

#### I. Background

On July 25, 2017, Legend Bank, dba OREAL, Inc. (OREAL) filed an application for a rate/tariff change. On October 3, 2017, the Administrative Law Judge (ALJ) issued Order No. 3 deeming the application administratively complete and requiring Staff to file a procedural schedule by October 10, 2017. Therefore, this pleading is timely filed.

#### II. Request to suspend rates

Based on the magnitude of the proposed rate change, Staff recommends that the commission suspend the effective date of OREAL's requested rate increase pursuant to Tex. Water Code § 13.1871(g) (West 2016).

### III. Request for Referral

The Texas Water Code permits the Commission to "set the matter for hearing on its own motion at any time within 120 days after the effective date of the rate change." Staff has determined that there are factual disputes associated with OREAL's cost of service that need to be

adjudicated. Given these factual disputes, Staff requests that the Commission refer this proceeding to the State Office of Administrative Hearings.

## IV. Conclusion

Staff recommends the Commission suspend OREALs requested rate increase and refer this proceeding to the State Office of Administrative Hearings.
