QUADVEST, L.P.'S REQUEST FOR EXTENSION

On September 12, 2018, the Administrative Law Judge issued Order No. 13 establishing a revised deadline of October 13, 2018 for Quadvest, L.P. (“Quadvest”) and Public Utility Commission Staff (“Commission Staff”) to file their joint proposed findings of fact and conclusions of law. As reported in the previous requests for extension, Commission Staff has been evaluating the tariff relevant to this docket in a related docket - Docket No. 47072. Quadvest and Commission Staff cannot submit joint proposed findings of fact and conclusions of law in this docket until the tariff in Docket No. 47072 has been reconciled. Quadvest transmitted a revised proposed tariff to Commission Staff for review in Docket No. 47072 on March 19, 2018, and the parties subsequently filed the revised proposed tariff in that docket on May 9, 2018 (Docket No. 47072, Item No. 28). The parties subsequently recognized that three other pending dockets, relating to a request for a pass-through rate change, impacted the tariff being considered in Docket No. 47072. Those Dockets are 48041, 48051, and 48052. The parties abated the proceedings in Docket No. 47072 on May 30, 2018 to provide the parties time to resubmit the revised tariff following the decisions in the three pass-thru dockets (Docket No. 47072, Item No. 29). The parties resubmitted the revised tariff pursuant to a Second Amended Joint Motion filed on June 28, 2018 (Docket No. 47072, Item No. 33), following the approval of those pass-thru dockets. On July 24, 2018, the Administrative Law Judge issued an order admitting the evidence

submitted by the parties. The parties continue to await a final order in the matter following the July 24, 2018 order.

Accordingly, Quadvest hereby requests that the deadline to file the joint proposed findings of fact and conclusions of law be extended an additional thirty (30) days from the October 13, 2018 deadline - to November 12, 2018, to allow time for consideration and action on the Second Amended Joint Motion in Docket No. 47072. The undersigned represents that this request is not being made for the purpose of delay. The undersigned has consulted with Joshua Adam Barron, counsel for the PUC, who has stated he has no objection to this request.
