COMMISSION STAFF'S RECOMMENDATION ON NOTICE

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest and Recommendation on Notice. In support thereof, Staff shows the following:

I. BACKGROUND

On July 28, 2017, Mustang Special Utility District (Mustang) filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 11856 and sewer CCN No. 20930 in Denton and Collin County.

In Order No. 3, issued November 3, 2017, Staff was ordered to file a recommendation on sufficiency of notice. Mustang filed their proof of notice on November 21, 2017. Staff apologizes for this late filed recommendation, and for any inconvenience caused by this delay.

II. RECOMMENDATION ON NOTICE

Staff has reviewed the applicant's affidavits of notice filed on November 21, 2017 and recommend they be found sufficient. Notice was mailed on November 10, 2017 and notice was published in a newspaper for two consecutive weeks on November 10, 2017 and November 17, 2017.

III. PROCEDURAL SCHEDULE

Staff recommends the notice be found sufficient. Staff therefore proposes the following procedural schedule:
