COMMISSION STAFF'S RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Recommendation on Administrative Completeness.

I. BACKGROUND

On August 7, 2017, Undine Texas, LLC (Undine) and Consumers Water, Inc. (collectively, Applicants) filed an application for approval of the sale, transfer, or merger of certificate rights in Harris and Montgomery counties (Application).¹ Supplements to the application were filed on August 11, 2017 and August 28, 2017.

On August 7, 2017, Undine also filed a motion for waiver of notice and hearing.²

On August 8, 2017, Order No. 1 was entered, requiring Staff to file a recommendation on administrative completeness by September 7, 2017. This pleading is timely filed.

II. RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS

Consistent with the attached memorandum of Leila Guerrero, Water Utility Regulation Division, Staff recommends that the application be deemed sufficient for filing and found to be administratively complete for the purpose of further review.

With respect to Undine's motion for waiver of a hearing, Staff opposes Undine's motion at this time. Staff continues to review the merits of the Application, and Staff has not determined at this time whether it believes a hearing will be necessary. Staff notes that the Commission is permitted 120 days from the filing of the Application and the completion of notice, if any is required, before informing the Applicants whether a hearing will be required in this proceeding.³

Further, Staff does not support Undine's motion for waiver of notice. However, Staff recommends that notice be provided consistent with Ms. Guerrero's memorandum and that the scope of notice be narrowed, similar to the requirements ordered in Docket No. 47396.⁴

Staff notes that 16 Tex. Admin. Code § 24.109(c) (TAC) requires notice be provided to affected customers and other affected parties, and 16 TAC § 24.109(d) requires that notice be provided to additional entities, which the Commission may waive if the requested area does not include any unserved area.

Staff recommends that notice to additional entities be waived as described in 16 TAC § 24.109(d), due to the requested area only including certificated areas (i.e., a "straight transfer") and not requiring a change to existing CCN boundaries. Staff also recommends that notice be limited to only current customers and not include cities and neighboring retail public utilities.

III. RECOMMENDATION REGARDING PROCEDURAL SCHEDULE

Staff is unable to propose a procedural schedule at this time until Staff is aware of what notice, if any, will be required.

If notice is required, Staff proposes that the Applicants be required to file a proof of notice with the Commission. Staff further proposes to file a recommendation on the sufficiency of notice, which will include a proposed procedural schedule, within 10 days of the filing of the Applicants' proof of notice.

If notice is not required, Staff proposes to file a recommendation on a proposed procedural schedule within 10 days of the filing of an order granting Undine's motion for waiver of notice.

SUBJECT: Docket No. 47477, Application of Consumers Water, Inc. and Undine Texas, LLC for Sale, Transfer, or Merger (STM) of Facilities and Certificate Rights in Harris and Montgomery Counties

On August 7, 2017, Consumers Water, Inc. (Consumers or Seller) and Undine Texas, LLC, (Undine or Purchaser), (collectively Applicants) filed an application for the sale, transfer, or merger of facilities and certificate rights in Harris and Montgomery Counties pursuant to Texas Water Code Ann. § 13.301 (TWC) and the 16 Tex. Admin. Code § 24.109 (TAC). Specifically, Undine seeks approval to acquire facilities and to transfer water service area from Consumers under Certificate of Convenience and Necessity (CCN) No. 10347. The requested area includes 14 public water systems, approximately 1,518 acres and 1,746 current customers. Undine is requesting a waiver of notice and hearing pursuant to TWC § 13.301.

Staff has reviewed the application and recommends the application be deemed sufficient for filing and administratively complete.

Staff does not support the waiver of notice. If notice is required, Staff recommends that the scope of notice be narrowed, similar to the requirements ordered in Docket No. 47396,¹ which included a 20 day comment period and required Undine to issue notice to:

- a) the county judge of each county and each groundwater conservation district that is wholly or partly included in the requested area; and
- b) any customers transferred, or other affected parties in the requested area.

Staff recommends that notice to additional entities as described in 16 TAC § 24.109(d) be waived due to the requested area only including certificated area (i.e., a "straight transfer") and not requiring change to existing CCN boundaries.

Lastly, Staff recommends that within 30 days of the Commission order, the Applicants file a copy of the actual notice along with a signed affidavit indicating that the notice was given. It is recommended that the Applicants use the attached notice and affidavit to meet these requirements.

The sale is scheduled to take place as approved by the Commission (V.T.C.A., Water Code § 13.301). The transaction and the transfer of the CCN includes the following subdivisions:

Greengate Acres Subdivision - PWS ID 1010132

The area subject to this transaction is located approximately 9 miles east of downtown Tomball, Texas, and is generally bounded on the north by Spring Stuebner Rd; on the east by Windsor Castle Dr.; on the south by FM 2920; and on the west by Glenbranch Dr in Harris County. The total area being requested includes approximately 117 acres and serves 99 current customers.

Highland Mobile Home Subdivision - PWS ID 1010285

The area subject to this transaction is located approximately 9 miles north-northwest of downtown Baytown, Texas, and is generally bounded on the north by Greenbow Ln; on the east by N Crosby Lynchburg Rd; on the south by Lochness Dr; and on the west by a line 850' west of N Crosby Lynchburg Rd in Harris County.

The total area being requested includes approximately $\underline{10}$ acres and serves $\underline{25}$ current customers.

Highland Ridge Subdivision - PWS ID 1010157

The area subject to this transaction is located approximately 8 miles north-northwest of downtown Baytown, Texas, and is generally bounded on the north by Loch Katrine St; on the east by Braemer Rd; on the south by Barbers Hill Rd; and on the west by Sralla Rd in Harris County.

The total area being requested includes approximately 52 acres and serves 196 current customers.

Huffman Heights Subdivision - PWS ID 1010700

The area subject to this transaction is located approximately 12 miles west of downtown Dayton, Texas, and is generally bounded on the north by Success Ln; on the east by Crosby Huffman Rd; on the south by Darden Dr; and on the west by Faraway Ln in Harris County.

The total area being requested includes approximately 48 acres and serves 119 current customers.

Joy Village - PWS ID 1700021

The area subject to this transaction is located approximately <u>9</u> miles <u>south-southeast</u> of downtown <u>Cleveland</u>, Texas, and is generally bounded on the north by <u>Joy Village Dr</u>; on the east by <u>FM 2090</u>; on the south by <u>Carol Ln</u>; and on the west by <u>a line 700' east of Usher Ln</u> in Montgomery County. The total area being requested includes approximately <u>55</u> acres and serves <u>52</u> current customers.

Lakewood Colony - PWS ID 1700029

The area subject to this transaction is located approximately <u>15</u> miles <u>southeast</u> of downtown <u>Conroe</u>, Texas, and is generally bounded on the north by <u>Lakeview Dr</u>; on the east by <u>FM 1314</u>; on the south by <u>Southridge Dr</u>; and on the west by <u>Westgrove Ln</u> in Montgomery County. The total area being requested includes approximately <u>40</u> acres and serves <u>57</u> current customers.

Meadowlake Estates - PWS ID 1010287

The area subject to this transaction is located approximately <u>13</u> miles <u>northeast</u> of downtown <u>Houston</u>, Texas, and is generally bounded on the north by <u>Little York Rd</u>; on the east by <u>Sheldon Reservoir</u>; on the south by <u>Avion St</u>; and on the west by <u>SL 8</u> in Harris County.

The total area being requested includes approximately <u>158</u> acres and serves <u>219</u> current customers.

Peach Creek Colony - No Current Customers

The area subject to this transaction is located approximately <u>12</u> miles <u>south-southeast</u> of downtown <u>Cleveland</u>, Texas, and is generally bounded on the north by <u>Peach Creek Dr</u>; on the east by <u>Peach Creek</u>; on the south by <u>Oak Hill Dr</u>; and on the west by <u>US 69</u> in Montgomery County. The total area being requested includes approximately 100 acres and serves 0 current customers.

Peach Creek Oaks Subdivision - PWS ID 1700051

The area subject to this transaction is located approximately <u>14</u> miles <u>south-southeast</u> of downtown <u>Cleveland</u>, Texas, and is generally bounded on the north by <u>a line 220' north of Pine Dr</u>; on the east by <u>Roadway Ln</u>; on the south by <u>SH 99</u>; and on the west by <u>Peach Creek</u> in Montgomery County. The total area being requested includes approximately <u>83</u> acres and serves <u>70</u> current customers.

Pioneer Trails Subdivision - PWS ID 1700114

The total area being requested includes approximately <u>318</u> acres and serves <u>133</u> current customers.

The area subject to this transaction is located approximately <u>19</u> miles <u>southeast</u> of downtown <u>Conroe</u>, Texas, and is generally bounded on the north by <u>Old Sorters Rd</u>; on the east by <u>a line 200' east of E</u> <u>Terrace Dr</u>; on the south by <u>Lavone Dr</u>; and on the west by <u>Enloe Rd</u> in Montgomery County. The total area being requested includes approximately <u>103</u> acres and serves <u>109</u> current customers.

Spring Forest Subdivision - PWS ID 1700033

The area subject to this transaction is located approximately <u>13</u> miles <u>south</u> of downtown <u>Conroe</u>, Texas, and is generally bounded on the north by <u>Rayford Rd</u>; on the east by <u>a line 730' east of Wild</u> <u>Rose Dr</u>; on the south by <u>Old Ox Rd</u>; and on the west by <u>a line 270' west of W Hawthorne Dr</u> in Montgomery County.

The total area being requested includes approximately <u>252</u> acres and serves <u>258</u> current customers.

Springmont Subdivision - PWS ID 1010255

The area subject to this transaction is located approximately <u>16</u> miles <u>south</u> of downtown <u>Conroe</u>, Texas, and is generally bounded on the north by <u>FM 2920</u>; on the east by <u>a line 250' east of Nanette</u> <u>Ln</u>; on the south by <u>Old Holzwarth Rd</u>; and on the west by <u>Sunshine Ln</u> in Harris County. The total area being requested includes approximately <u>42</u> acres and serves <u>175</u> current customers.

Tall Cedars Mobile Home Subdivision - PWS ID 1010219

The area subject to this transaction is located approximately <u>13</u> miles <u>southwest</u> of downtown <u>Dayton</u>, Texas, and is generally bounded on the north by <u>a line 175' north of Florabunda Ln</u>; on the east by <u>FM 2100</u>; on the south by <u>a line 200' south of Rose Elfe Ln</u>; and on the west by <u>a line 425' west of</u> <u>Zetak Ln</u> in Harris County.

The total area being requested includes approximately <u>61</u> acres and serves <u>57</u> current customers.

The area subject to this transaction is located approximately <u>6</u> miles <u>south</u> of downtown <u>Conroe</u>, Texas, and is generally bounded on the north by <u>Trade Center Ditch/College Park Ditch</u>; on the east by <u>West Fork San Jacinto River</u>; on the south by <u>Kingfisher Dr and Wood Hollow Dr</u>; and on the west by <u>Gleneagle Dr</u> in Montgomery County.

The total area being requested includes approximately 57 acres and serves 0 current customers.

Urban Acres Subdivision - PWS ID 1010252

The area subject to this transaction is located approximately <u>11</u> miles <u>north-northeast</u> of downtown <u>Houston</u>, Texas, and is generally bounded on the north by <u>a line 1500' north of E Mt Houston Rd</u>; on the east by <u>a line 170' east of Urban Dr</u>; on the south by <u>E Mt Houston Rd</u>; and on the west by <u>a line 175' west of Nanette Dr</u> in Harris County.

The total area being requested includes approximately 22 acres and serves 177 current customers.

Hearing requests, comments or requests to intervene should be filed with the:

within thirty (30) days from the date of this publication or notice. A public hearing will be held only if a legally sufficient hearing request is received or if the Commission on its own motion requests a hearing. Only those individuals who submit a written hearing request will receive notice if a hearing is scheduled.

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.

Persons who wish to intervene in the proceeding or comment upon action sought should contact the Public Utility Commission, P.O. Box 13326, Austin, Texas 78711-3326, or call the Public Utility Commission at (512) 936-7120 or (888) 782-8477. Hearing- and speech-impaired individuals with text telephones (TTY) may contact the commission at (512) 936-7136.
