**JOINT MOTION TO ADMIT EVIDENCE**

COMES NOW Undine Texas LLC (Undine), together with the Staff of the Public Utility Commission of Texas (Staff) representing the public interest and Consumers Water, Inc. (Consumers) (collectively, Parties), and files this Joint Motion to Admit Evidence. In support thereof, the Parties show the following:

**I. BACKGROUND**

On August 7, 2017, Undine and Consumers (collectively, Applicants) filed an application with the Public Utility Commission of Texas (Commission) for the sale, transfer, or merger of facilities and certificate rights in Harris and Montgomery Counties, Texas. Consumers sought approval to transfer all water facilities and service area under certificate of convenience and necessity (CCN) No. 10347 to Undine. The requested area includes approximately 1,518 acres and 1,746 current customers.

On December 4, 2017, Order No. 6 was issued, permitting the transaction to proceed and requiring the filing of documents demonstrating the close of the transaction. On July 16, 2018, Applicants filed the required closing documents.

On July 30, 2018, Staff filed a recommendation that the Applicants' closing documents were consistent with the applicable Commission rules.

On August 2, 2018, Order No. 8 was issued finding Undine's closing documentation sufficient.

On October 3, 2018, the Parties filed a Joint Motion for Adoption of a Proposed Notice of Approval.

On November 20, 2018, Order No. 10 was issued, requiring parties to file a joint motion to admit evidence by November 30, 2018. Therefore, this pleading is timely filed.

## **II. JOINT MOTION TO ADMIT EVIDENCE**

8. Applicants' Notice of Proof that Transaction has been Completed and Customer Deposits have been Properly Addressed, filed on July 16, 2018 (AIS Item No. 34);
9. Commission Staff's Recommendation on Sufficiency of Closing Documents, filed on July 30, 2018 (AIS Item No. 36);
10. Undine's revised Consent Form to the final map and certificate, filed on September 28, 2018 (AIS Item No. 42); and
11. The final map and certificate, filed on October 3, 2018, attached to the Joint Motion for Adoption of Proposed Notice of Approval (AIS Item No. 43).

### III. CONCLUSION

The Parties have agreed that Undine is authorized to file this pleading on their behalf. Therefore, the Parties respectfully request that the Commission grant the Joint Motion to Admit Evidence.
