## **UNDINE TEXAS LLC'S FIRST ERRATA TO APPLICATION**

Undine Texas, LLC ("Undine") filed an Application for the Sale, Transfer, or Merger of Consumers Water, Inc. ("Consumers") Facilities and Certificate Rights in Harris and Montgomery Counties on August 7, 2017 (the "Application"). On August 18, 2017, in Docket No. 46731, the Commission issued a Notice of Approval granting the petition of Grand Oaks Partners, LLC ("Grand Oaks") to remove properties owned by Grand Oaks Partners from the certificated service area of Consumers. Therefore, it is necessary to revise two maps included in Undine's Application to reflect the removal of the Grand Oaks properties from the service area that will be transferred to Undine upon approval of the Application.

Specifically, the maps filed as "Attachment K" page 115 (General Location Map) and "Attachment K" page 127 (Spring Forest Subdivision) are being revised to remove the Grand Oaks properties. The removal of the Grand Oaks properties results in a total acreage of 1518 acres being transferred to Undine, as compared to the originally-stated acreage of 1523 total acres. The total acreage in the Spring Forest Subdivision is now 252 acres, instead of the originally-stated 257 acres. The acreage count for Spring Forest Subdivision on page 134 of the Application should also be revised to be 252 instead of 257 acres. There is no change in the number of customers in the Spring Forest Subdivision.

The attached pages should be substituted in place of the original pages 115 and 127 of "Attachment K."
