

If the Commission approves the proposed order filed in this docket, I recommend that the Commission make the following modifications for the sake of consistency with other Commission orders.

- a) Ordering paragraph 4 should be modified, as follows:
 - 4. The Commission's official service area boundary maps for Manville WSC shall reflect this change, as shown in the attached map.
- b) The following new ordering paragraph should be added:
OP. A copy of Manville WSC's amended water CCN No. 11144 is attached to this Order.
