**ORDER NO. 2
DEEMING APPLICATION ADMINISTRATIVELY COMPLETE,
ADDRESSING NOTICE, AND ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses Commission Staff's September 18, 2017 recommendation regarding the application of Maxwell Water Supply Corporation for approval of a contract to recertify service area back to Maxwell WSC in accordance with a settlement agreement reached by the parties in an Agreed Order issued by the 201st District Court of Travis County. Staff recommended that the petition be processed using the authority in Texas Water Code § 13.248 and 16 Texas Administrative Code § 24.117.

Commission Staff found the application to be administratively complete and recommended that no additional notice was necessary since the contract, the subject of this petition, was discussed at a meeting of Maxwell WSC's board of directors and at a meeting of the City Council of the City of San Marcos.¹ There are no current customers affected by this application. Commission Staff also proposed a procedural schedule for continued processing of this proceeding.

Consistent with Commission Staff's recommendation, the application is deemed sufficient and administratively complete. Notice of the application was published in the *Texas Register* on September 8, 2017. No additional notice is necessary.
