COMMISSION STAFF'S REQUEST FOR AN EXTENSION

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Request for an Extension.

On August 24, 2017, City of Cibolo and Green Valley Special Utility District (collectively, Applicants) filed an application pursuant to Texas Water Code § 13.248 (West 2008) (TWC) for approval of an agreement that would amend certificates of convenience and necessity (CCN) in Guadalupe County. On August 30, 2017, Order No. 1 was entered, requiring Staff to provide a recommendation regarding the application, proposed notice, and procedural schedule by September 25, 2017. This pleading is timely filed.

Staff has conferred with a representative for the Applicants, who has indicated that the Applicants intend to provide additional information regarding the application. As a result, Staff respectfully requests an extension of time for Staff to provide a recommendation regarding the application, proposed notice, and procedural schedule until October 9, 2017. A representative for Applicants has indicated that Applicants are not opposed to Staff's request.

Staff notes that 16 Tex. Admin. Code § 24.8 requires that certain application be reviewed for administrative completeness within 30 days of the date on which the application is file stamped. To the extent a good cause exception to this rule may be necessary, Staff respectfully requests a good cause exception.




