HMSC, LLC REPLY TO BOTH MCCOY'S RESPONSE AND COMMISSION STAFF'S FINAL RECOMMENDATION

COMES NOW, HMSC, LLC, petitioner in this matter, and files this reply to both McCoy's Response and Public Utility Commission of Texas ("Commission") Staff's Final Recommendation, and presents the following:

I. BACKGROUND

On August 30, 2017, HMSC, LLC ("HMSC") filed a petition for a streamlined expedited release of 292.16 acres (the "Property") from McCoy Water Supply Corporation's ("McCoy") water certificate of convenience and necessity No. 10649 in Atascosa County, Texas, pursuant to Tex. Water Code Ann. § 13.254(a-5) (West 2008 and Supp. 2016) and 16 Tex. Admin. Code § 24.113(l). HMSC asserted in its Petition and continues to assert that the Property is not receiving water service from McCoy¹.

On September 28, 2017, McCoy filed a motion to intervene. McCoy also filed a response to Order No. 3 on October 17, 2017. On October 24, 2017, Commission staff requested a one-week extension to file a recommendation on final disposition of Petitioner's application. In Order No. 4, filed on October 26, 2017, the Administrative Law Judge ordered Staff to file a recommendation on final disposition by October 31, 2017 and revised the procedural schedule. On October 31, 2017, Commission Staff filed the Commission Staff's Recommendation on Final

Disposition recommending approval of Petitioner's application. The revised procedural schedule set forth a deadline for HMSC to file a reply to both McCoy's response and Commission Staff's final recommendation of November 7, 2017. In Order No. 5, filed on November 8, 2017, the Administrative Law Judge granted an extension to HMSC until 5:00 pm on November 9, 2017 to file its reply to both McCoy's Response and Commission Staff's Final Recommendation. Therefore, this pleading is timely filed.

Concurrently with the filing of McCoy's response on October 17, 2017, McCoy also filed an action against Petitioner, the City of Jourdanton, the Commission and Commissioners Kenneth Anderson, Jr., and Brandy Marty Marquez, in their official capacity as Commissioners, and Brian H. Lloyd in his official capacity as Executive Director of the Commission in the United States District Court for the Western District of Texas San Antonio Division ("Western District"). The lawsuit is currently still pending in the Western District; however, on November 2, 2017, the judge ordered an extension of the deadline for defendants to file answers in the lawsuit, and ordered plaintiff to file a status report by December 1, 2017.

II. STATUTORY APPROVAL DEADLINE

Pursuant to 16 TAC § 24.113(l)(5), the Commission must render a decision on a petition for expedited release "no later than the 60th calendar day after a presiding officer by order determines that the petition is administratively complete." Order No. 3. Issued on October 10, 2017, deemed HMSC's Petition administratively complete; therefore the 60-day deadline for administrative approval is December 11, 2017.²

III. HMSC REPLY TO BOTH MCCOY'S RESPONSE AND COMMISSION STAFF'S FINAL RECOMMENDATION

HMSC agrees with Commission Staff's final recommendation that the petition filed on August 30, 2017 by granted. As asserted in its petition, HMSC was "not receiving service of the type that the current CCN holder is authorized to provide under the applicable CCN" at the Property at the time the petition was filed. Additionally, as asserted in its petition and as set forth in Commission Staff's Final Recommendation, HMSC asserts that it has met all requirements and is eligible for streamlined expedited release pursuant to Tex. Water Code Ann. § 13.254(a-5) (West 2008 and Supp. 2016) and 16 Tex. Admin. Code § 24.113(l).

IV. CONCLUSION

For the reasons stated above, HMSC agrees with Commission Staff's final recommendation and respectfully requests that its petition be granted.
