#### COMMISSION STAFF'S SUPPLEMENT TO ITS FINAL RECOMMENDATION

**COMES NOW** the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Supplement to its Final Recommendation.

#### I. BACKGROUND

On September 6, 2017, the City of Aubrey (Applicant) filed with the Public Utility Commission of Texas (Commission) an application to amend its water and sewer Certificates of Convenience and Necessity (CCN) and to decertify a portion of Mustang Special Utility District's (SUD) service area in Denton County, Texas. On November 9, 2017, Order No. 3 was issued, setting January 9, 2018 as the deadline for Staff to file its final recommendation, if no hearing was requested. Staff filed its final recommendation on January 9, 2018.

#### II. STAFF'S SUPPLEMENT TO ITS FINAL RECOMMENDATION

Staff wishes to supplement its final recommendation with the attached maps and certificates. These maps and certificates were sent to the Applicant on December 14, 2017 and were consented to by Mustang Special Utility District and the City of Aubrey on December 28, 2017 and December 29, 2017 respectively.

#### III. CONCLUSION

For the reasons specified above, Staff respectfully requests an order consistent with the above request.


