



Hopper, by the deed recorded in Instrument No. 01-91486, of the Deed Records of Denton County, Texas, and both of the tracts of land conveyed to Garland & Terri Wilson, by the deeds recorded in Instrument No. 2009-73486 and Instrument No. 2010-44908, of the Deed Records of Denton County, Texas, and all of the four tracts of land conveyed to G & S Landscaping Inc., by the deeds recorded in Instrument No. 97-0079357, Instrument No. 97-0005715 and Instrument No. 98-0000206, of the Deed Records of Denton County, Texas. Hopper Tract, and the South boundary line of the tract of land conveyed to Aubrey Church of Christ, by Instrument No. 99-0020994, of the Deed Records of Denton County, Texas, to a point at the Northeast corner of said Jack S. Hopper Tract and the most Northerly Northwest corner of the aforesaid 60.542 acre tract of land conveyed to Aubrey Realty & Development LLC, by the deed recorded in Instrument No. 2016-16961, of the Deed Records of Denton County, Texas;
- THENCE N 89° 28' 42" E 1260.68 feet, along the North boundary line of said 60.542 acre tract of land, to a point at the Northeast corner of said 60.542 acre tract;
- THENCE N 89° 26' 52" E 1779.62 feet, along the North boundary line of the aforesaid tracts of land conveyed to G & S Landscaping Inc., to a point at the Northeast corner of the tract of land conveyed to G & S Landscaping, by the deed recorded in Instrument No. 97-0079357, of the Deed Records of Denton County, Texas;

- THENCE S 02° 59' 57" E 1645.53 feet, along the East boundary line of said G & S Landscaping Inc Tract, to a point at the Southeast corner of said G & S Landscaping Inc Tract;
- THENCE N 88° 28' 46" W 1894.87 feet, along the South boundary lines of the aforesaid four tracts of land conveyed to G & S Landscaping Inc, to a point at the Southwest corner of said G & S Landscaping Inc Tract, being the Southeast corner of the aforesaid 60.542 acre tract of land conveyed to Aubrey Realty & Development LLC, by the deed recorded in Instrument No. 2016-16961, of the Deed Records of Denton County, Texas;
- THENCE N 88° 42' 04" W 2881.37 feet, along the South boundary line of said 60.542 acre Tract and also the South boundary line of the aforesaid 9.882 acre tract of land conveyed to Aubrey Realty & Development LLC, to the POINT OF BEGINNING containing approximately 169 acres of land.
