Additional proof of active violations not pertaining to capacity is being prepared by BCWSC and will be submitted in a Supplement to Receiver's Response To Commission Staff's Third Request for Information to Thunderbird Point Water System and Bi-County Water Supply Corporation Question No. Staff 3-1 in the near future.
