

Other issues to be addressed in this case are those set forth in Commission Rules, Chapter 24, Subchapter B, unless they are duplicative of the provisions of the Texas Water Code set forth above. These are the statutory provisions of the Texas Water Code that pertain and govern rate changes by utilities in the in the State of Texas to which these provisions of the Texas Water Code govern, as well as the regulatory rules of the Commission over which it has jurisdiction and over which its rules apply.


