DEFINITIONS

- A. "Undine," "Purchaser," "the Company," or "you" refers to Undine Texas Environmental, LLC f/k/a EMCAD Water and Wastewater, LLC and any person acting or purporting to act on their behalf, including without limitation, attorneys, agents, advisors, investigators, representatives, employees or other persons.

- Please provide a notarized affidavit signed by an appropriate representative of the parent company owner or operator of Undine Texas Environmental as a written guarantee to cover any operations and maintenance cash shortages in order to satisfy the operations test of 16 Tex. Admin. Code § 24.11(e)(3).
