## **UNDINE TEXAS, LLC'S REQUEST FOR EXTENSION**

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

Comes Now Undine Texas, LLC ("Undine") and files this Request for Extension.

On January 23, 2018, Order No. 4 was entered establishing July 22, 2018 as the deadline for Applicants to complete the transaction. For the reasons set forth herein, Undine hereby requests a thirty day extension, to August 21, 2018, to complete the transaction.

I.

### **DISCUSSION**

The Commission rules provide that the 180-day deadline to complete the transaction may be extended for good cause shown. 16 Tex. Admin. Code § 24.109(o). Undine and the seller, Gulf Coast Utility Company, Inc., have been working diligently since the entry of Order No. 4 to close the transaction within the 180-day timeframe. Despite those efforts, the parties recently identified certain unanticipated impediments to closing. Those impediments have been addressed; however, the delay they caused has required that the parties reschedule the closing to an anticipated date of August 1, 2018. In order to protect against any other potential short-term delays, Undine seeks an extension of 30 days. Undine does not seek this extension for purposes of delay.

#### **CONCLUSION**

Undine respectfully requests that the Request for Extension to August 21, 2018 be granted. The undersigned has consulted with counsel for Commission Staff, who has indicated they do not oppose this request.
