**JOINT SUPPLEMENT TO
PROPOSED NOTICE OF APPROVAL**

COMES NOW the Commission Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and Undine Texas Environmental, LLC f/k/a EMCAD Water and Wastewater, LLC (Undine Texas Environmental) (together, the parties) to file this Joint Supplement to the Proposed Notice of Approval. On December 6, 2017, the parties filed the Joint Motion for Admission of Evidence and Adoption of Proposed Notice of Approval. The new sewer Certificates of Convenience and Necessity (CCN) Nos. 20816, 20832, and 21019 for approval of the name change of the certificate holder are attached to this supplement.

The parties further note that sewer CCN No. 20816 is partially located in Parker County as well as Tarrant County. Therefore, Finding of Fact No. 1 in the Proposed Notice of Approval should be amended to include Parker County and state as follows:

1. On September 22, 2017, EMCAD filed a Request for Name Change from EMCAD Water and Wastewater, LLC to Undine Texas Environmental, LLC for sewer CCN Nos. 21019, 20816, and 20832 in Johnson, Parker, and Tarrant Counties, Texas.



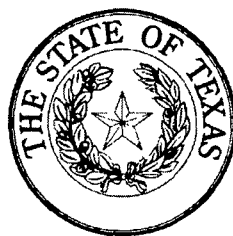
