**SUPPLEMENT TO CCN NAME CHANGE APPLICATION**

On September 22, 2017, Undine Texas Environmental, LLC (f/k/a EMCAD Water and Wastewater, LLC) submitted a Notification of Name Change in the referenced docket. Pursuant to discussion with Staff, Undine submits the following supplemental information in support of its Application. Undine Texas Environmental, LLC seeks to have the name on wastewater CCN Nos. 21019, 20816, and 20832 changed from EMCAD Water and Wastewater, LLC to Undine Texas Environmental, LLC. As explained further below, the Commission has already performed a review in Docket No. 45745 of Undine Texas, LLC’s financial, managerial, and technical capability for providing continuous and adequate service to the certificated service areas at issue.

1. Additional Background:

*Undine Texas, LLC, parent company to Undine Texas Environmental, LLC, purchased all of the issued and outstanding membership interests of EMCAD Water and Wastewater, LLC, effective September 28, 2016. That transaction was authorized and approved pursuant to PUC Docket No. 45745. EMCAD Water and Wastewater, LLC subsequently changed its name to Undine Texas Environmental, LLC. EMCAD Water and Wastewater, LLC, now Undine Texas Environmental, LLC, provides wastewater services to customers in Johnson and Tarrant Counties through three wastewater systems, under CCN No. 's 21019, 20816, and 20832.*


