## ORDER NO. 2 ADDRESSING COMMISSION STAFF'S SUFFICIENCY RECOMMENDATION

This Order addresses Commission Staff's October 17, 2017, recommendation regarding processing, sufficiency, and proposed procedural schedule. Commission Staff recommended that EMCAD Water and Wastewater, LLC's name change application be processed administratively, similar to Docket No. 45932.

Commission Staff also recommended, following review of the application and October 16, 2017 supplement, that the application be found sufficient and that notice be governed by 16 Texas Administrative Code § 22.55 and that notice of the application be submitted to the *Texas Register* for publication.

For purposes of moving this matter forward, the administrative law judge tentatively finds the amended application and proposed method of notice sufficient. However, while the steps to possible completion of this case can be similar to those taken in Docket No. 45932, the application<sup>2</sup> in Docket No. 45932 is governed by specific statutory and regulatory authority applicable to a telecommunications provider. Those authorities do not apply to a water and sewer utility.

The following procedural schedule is adopted:
