TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

On October 2, 2017, Administrative Law Judge Jeffrey J. Huhn issued Order No. 1 in this matter in which he ordered the parties to propose a procedural schedule if the parties had received agreement on compensation. Mustang Special Utility District ("Mustang") and the former CCN holder, Terra Southwest, Inc., have indeed reached agreement on all aspects of compensation, including the monetary amount, thus the only remaining matter is for the Commission to approve that agreement pursuant to 16 TAC § 24.113-(0)(6). Given this agreement, we believe it is unlikely that any person will contest this matter. Therefore, we ask that this is processed as an uncontested matter.

Accordingly, Mustang proposes the following procedural schedule:

Date notice of intent to provide service filed and date parties filed the compensation agreement	September 28, 2017
Deadline for Commission Staff to file final recommendation	October 19, 2017
Deadline for parties to file proposed order including findings of fact and conclusions of law	October 30, 2017
90 day deadline for Notice of Approval ¹	December 27, 2017

¹ Under 16 Texas Administrative Code § 24.113(o)(3), the total compensation for any property identified as useless or valueless will be determined no later than the 90th date after the date the notice intent is filed.

Mustang has consulted with Commission Staff and they agree with this proposed schedule.
