WYNNE/JACKSON, INC'S RESPONSE TO COMMISSION STAFF'S FINAL RECOMMENDATION

TO THE PUBLIC UTILITY COMMISSION OF TEXAS:

Wynne/Jackson, Inc. ("Wynne/Jackson") files this Response to the Commission Staff's Final Recommendation pursuant to the Administrative Law Judge's (the "ALJ") direction in Order No. 3. In support thereof, Petitioner respectfully shows the Public Utility Commission of Texas (the "PUC") the following:

I. THE PUC STAFF CORRECTLY DETERMINED THAT WYNNE/JACKSON'S PETITION SHOULD BE APPROVED AND GRANTED BY THE PUC

As the Staff stated in its Final Recommendation, Wynne/Jackson's Petition for the approximately 336.7 acre tract of property in Kaufman County more specifically described in the maps, deed, and digital data submitted by Wynne/Jackson (the "Property") is (1) at least 25 acres, (2) is not receiving water or sewer service, and (3) is in a county with a population of at least one million or a county adjacent to such a county as described by Tex. Water Code § 13.254(a-5) (TWC) and 16 Tex. Admin. Code § 24.113(l) (TAC). Wynne/Jackson submitted exhibits demonstrating that the Property is qualified for expedited release under Section 13.254(a-5). Therefore, by law, Wynne/Jackson is entitled to that release under TWC § 13.254(a-5).



Accordingly, Staff correctly found that the maps, digital data and affidavit provided by

Wynne/Jackson presented adequate information to demonstrate that the Property satisfies the

requirements of TWC § 13.254(a-5) and 16 TAC § 24.113(l). Staff recommends that the petition

for expedited release submitted to the PUC by Wynne/Jackson should be approved.

II. CONCLUSION AND PRAYER

Wynne/Jackson agrees with the Commission Staff's Final Recommendation. The

Property is at least 25 acres of contiguous property, is not receiving water or sewer service, and

is located within a qualifying county (Kaufman County), Wynne/Jackson is entitled to expedited

release of the Property from water Certificate of Public Convenience and Necessity No. 10846.

Wynne/Jackson respectfully requests that the Honorable Administrative Law Judge, prepare and

submit to the Commission a proposed order consistent with the Commission Staff's Final

Recommendation, and that the Commission adopt the proposed order before the end of the

statutory approval deadline on January 16, 2018. Wynne/Jackson further prays for all other

relief to which it is entitled by law.
