**TO THE HONORABLE PUBLIC UTILITY COMMISSION OF TEXAS:**


COMES NOW, Markout Water Supply Corporation ("Markout"), by and through its counsel, and files this Motion for Extension of Deadline. In support thereof, Markout would respectfully show as follows:

1. PUC Final Order, Item No. 13, issued January 12, 2018, ordered Markout to comply with the recording requirements of Texas Water Code (TWC) § 13.257(r) and (s) for the area in Kaufman County affected by the petition and submit to the Commission evidence of the recording no later than 31 days after receipt of the Final Order. The deadline to record is February 12, 2018.
2. Markout's staff is working with its consulting engineer currently to satisfy the requirements of TWC § 13.257(r) and (s), but does not believe they will meet the deadline imposed by the Final Order.
3. Markout requests an extension and believes 14 days will be adequate.

**WHEREFORE**, Markout Water Supply Corporation requests this Motion be granted and extend the deadline for recording requirements of TWC § 13.257(r) and (s) and submit to the Commission evidence of such recording no later than February 26, 2018.


