## TO THE PUBLIC UTILITY COMMISSION OF TEXAS:

COMES NOW, Markout Water Supply Corporation ("Markout WSC") and files this Motion to Intervene pursuant to 16 Tex. Admin. Code §§ 22.101, 22.103, and 22.104. In support thereof, Markout WSC would respectfully show as follows:

- 1. Markout WSC respectfully requests to intervene as a party in this proceeding. As Certificate of Convenience and Necessity ("CCN") holder, Markout WSC is a necessary party to this proceeding and has the right to intervene as it has justiciable interests which may be adversely affected by the outcome of this proceeding.
- 2. Wynne/Jackson, Inc. filed a petition to amend Markout WSC's CCN No. 10846 by expedited release on October 16, 2017 (the "Petition"), and Markout WSC timely files this Motion to Intervene.
