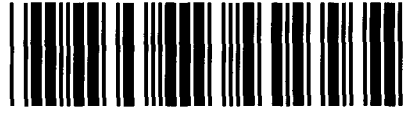

COMMISSION STAFF'S MOTION TO RESCHEDULE PREHEARING CONFERENCE

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas, representing the public interest, and moves to reschedule the prehearing conference. In support thereof, Staff shows the following:

I. MOTION

On October 17, 2017, Naomi Barron (Complainant) filed a formal complaint against Longspur Crossing Apartments (Longspur) and Westdale Management (Westdale)(collectively, Respondents). On December 4, 2017, the Public Utility Commission of Texas (Commission) referred this case to the State Office of Administrative Hearings (SOAH), requesting assignment of an Administrative Law Judge (ALJ) to conduct a hearing and issue a proposal for decision, if necessary. On December 6, 2017, SOAH issued Order No. 1, scheduling a prehearing conference for Friday, January 12, 2018 at 10 a.m.

Due to unavailability of Staff's counsel, Staff respectfully requests that the prehearing conference be rescheduled for one of the following dates: January 26, 2018; January 31, 2018; or February 7, 2018. Staff has conferred with Complainant and counsel for Respondents, who indicated that they are not opposed to the motion.

II. CONCLUSION

Staff respectfully moves for the prehearing conference to be rescheduled to a time on either January 26, 2018; January 31, 2018; or February 7, 2018.
