COUNTY OF TRAVIS

TO THE HONORABLE PUBLIC UTILITY COMMISSION OF TEXAS:

The undersigned ("Petitioner") acting pursuant to the provisions of Texas Water Code Chapter 13, respectfully petitions the Public Utility Commission of Texas (the "Commission") for expedited release of the lands hereinafter described from the certificated service territory of Woodland Hills Water Company, LLC ("Water Company") and would show the following:

I.

Petitioner is the owner of 6,985.106 acres of real property being a 6,980.02 acre and a 5.086 acre tracts further described by metes and bounds in **Exhibit "A"** attached hereto and hereby incorporated by reference for all purposes (the "Property"). Petitioner intends to file a petition with the Texas Commission on Environmental Quality to create a municipal utility district on the property. Attached as **Exhibit "B"** hereto is a copy of three (3) deeds evidencing Petitioner's fee ownership of the Property.

II.

Water Company is the holder of water Certificate of Convenience and Necessity No. 12388 (the "CCN"). The Property is located within the certificated water service territory of Water Company, as defined by the CCN.

III.

The Property is located within Liberty County. Liberty County is adjacent to Harris County which has a population of at least one million.

IV.

Petitioner affirms that the Property is not receiving water or sewer service from Water Company which has consented to this release of property as shown on the attached **Exhibit "C."**

٧.

Pursuant to Section 13.254(a-5) and (a-6) of the Texas Water Code, Petitioner is entitled to expedited release of the Property from the CCN because the Property: (i) is a tract of land at least 25 acres; (ii) is located within the CCN; (iii) is not receiving water or sewer service from

Water Company; and (iv) is located within a county adjacent to a county with a population of at least one million.

VI.

WHEREFORE, Petitioner prays that this Petition be deemed properly filed in accordance with Section 13.254(a-5) and (a-6) of the Texas Water Code; that this Petition be heard and granted in all respects; that the Commission enter an order releasing the Property from CCN No. 12388, and that such other orders, acts, procedures and relief be granted as are necessary and proper for the release of the Property from CCN No. 12388.




