RE: Docket No. 47730 Guadalupe-Blanco River Authority's (GBRA) to Application to Amend a
Sewer CCN in Guadalupe County

To Whom It May Concern:

On November 27, 2017, the Public Utility Commission, in reference to Docket No. 47730 *Application of Guadalupe-Blanco River Authority to Amend a Sewer Certificate of Convenience and Necessity in Guadalupe County*, issued a series of recommendations regarding public notifications. The recommendations were as follows:

1. Provide notice of the application to the following:
 - a. Any districts, utilities, and cities within two (2) miles of the proposed area.
 - b. The county judge of each county and each groundwater conservation district that is wholly or partly included in the proposed area to be certified.
 - c. Each city with an extraterritorial jurisdiction (ETJ) that is wholly or partly included in the proposed area to be certified.
 - d. Landowners who own a tract of land that is at least 25 acres and is wholly or partly located in the proposed area to be certified. The landowner information may be obtained from the county appraisal district tax rolls for the county or counties in which the proposed CCN is located.
 - e. Publish notice once each week for two (2) consecutive weeks in a newspaper of general circulation in Guadalupe County.
2. Provide notice to the following:
 - City of Sequin, CCN No. 20270
 - City of New Braunfels
 - New Braunfels Utilities, CCN No. 20282
 - Green Valley SUD, CCN No. 20973
 - Zipp Utility Co. LLC, CCN No. 21098
 - City of Santa Clara
 - Canyon Regional Water Authority
 - Comal County WID #3 – does not exist

 - Guadalupe County Judge Kyle Kutscher
3. Provide an accurate map delineating the requested service area with each individual notice to neighboring utilities and other affected parties. Information related to districts including addresses is to be obtained by the Applicant from the TCEQ website located at www.14.tceq.texas.gov/iwud/.
 4. File in the docket an affidavit specifying every person and entity to whom notice was provided and the date that the notice was provided within 30 days of the date of the notice. In addition, file the publishers' affidavit for proof of newspaper publication.

The recommended notifications were requested to be completed by December 29, 2017 - 30 days after the issuance of Order No. 2. However, the amount of time required to determine the appropriate parties for the notifications in recommendation 1 above as well as the upcoming Christmas holidays have negatively impacted our ability to meet the noted deadline.

As a result, GBRA respectfully requests an extension of 30 days such that the deadline to file the appropriate affidavits of notice is moved to January 29, 2018.
