Lone Star Groundwater Conservation District Increase

Dear Public Utility Commission of Texas:

Please find enclosed correspondence from the Lone Star Groundwater Conservation District (LSGCD) indicating that their "Pass Through" pumpage fees that they are charging as part of the county-wide Groundwater Reduction Plan will increase beginning January 1, 2018. This increase will affect the customers in the Woodland Oaks Subdivision, as well as some commercial customers located within the service area. Fees will be increasing from \$0.075/1,000 gallons to \$0.105/1,000 gallons (plus an additional \$0.015/1,000 gallons due to minor line loss). See the attached explanation of how the fee was calculated. Also enclosed are a spreadsheet indicating water pumped vs. water sold for the last 12 months, the notice to the customers of Woodland Oaks Utility Co. that will be included with the bills that will be mailed on November 22, 2017, and the current tariff.

This letter represents the formal request by Woodland Oaks Utility Company, Inc. to pass through the additional fees being charged by the Lone Star Groundwater Conservation District to its customers effective January 1, 2018.

Detailed Explanation for the Calculation of the LSGCD Pass-Through Gallonage Rate Adjustment

Woodland Oaks Utility Company, Inc. Water Tariff Fee Pass-Through Calculation for San Lone Star Groundwater Conservation District (LSGCD) Groundwater Reduction Plan (GRP) Water Gallonage Charge is:

$$AG = (G + B)/(1-L)$$

Where:

AG = adjusted Gallonage charge, rounded to the nearest cent for fee increase

G = Approved gallonage charge (per 1,000 gallons) for LSGCD GRP fee

B = change in district gallonage charge (per 1,000 gallons) for LSGCD GRP fee

L = system average line loss for the preceding 12 months not to exceed 0.15

And:

G = \$0.075/1,000 gallons

B = \$0.03/1,000 gallons

L = 9.3% or 0.093 for system average line loss (see following spreadsheet)

Therefore:

$$AG = (\$0.075 + \$0.03)/(1-0.093) = \$0.12/1,000 \text{ gallons}$$

Re: NOTICE OF WATER USE FEE RATES FOR CALENDAR YEAR 2018

Dear Mr. Woodring:

At its August 8, 2017, board meeting, the Board of Directors of the Lone Star Groundwater Conservation District ("District") approved a 10.5 cent per 1,000 gallons Water Use Fee rate for 2018, which applies to the total amount of groundwater you are authorized by permit to produce in calendar year 2018. The \$0.105/1,000-gallon rate goes into effect on January 1, 2018, and applies to all uses other than "agricultural use" as that term is defined in the District Rules.

The Water Use Fee rate for the Catahoula Aquifer remains unchanged at \$0.06 per 1,000 gallons, as does the agricultural use (\$1.00 per acre-foot) rate. The Groundwater Transport Fee for transportation of groundwater out of the District remains a fifty percent (50%) surcharge in addition to the District's water use fee for in-District use. The Minimum Regulatory Water Use Fee remains at \$10.00.

Dear Woodland Oaks Utility Customer:

We received notice from the Lone Star Groundwater Conservation District (LSGCD) regarding an increase in the "Pass Through" pumpage fees they are charging as part of the county-wide Groundwater Reduction Plan, effective January 1, 2018. As a result, you will see the LSGCD Fee increased from \$0.075/1,000 gallons to \$0.105/1,000 gallons with a 9.3% line loss effective January 1, 2018.

LSGCD Pass Through (AG = \$0.105/(1-.093) = \$0.12/1,000 gallons)

Present Billing Calculation for 7,000 gallons of usage in a month: \$75.92

Base bill: \$36.28

Utility Gallonage Rate: \$2.58/1,000 gallons X 7 = \$18.06

SJRA Pass Through: \$3.00/1,000 gallons x 7 = \$21.00

LSGCD Pass Through: $$0.083/1,000 \text{ gallons } \times 7 = 0.58

New Billing Calculation for 7,000 gallons of usage in a month: \$76.18

Base bill: \$36.28

Utility Gallonage Rate: \$2.58/1,000 gallons X 7 = \$18.06

SJRA Pass Through: \$3.00/1,000 gallons x 7 = \$21.00

LSGCD Pass Through: \$0.12/1,000 gallons x 7 = \$0.84

This tariff change is being implemented in accordance with the minor tariff changes allowed by 16 Texas Administrative Code §24.21. The cost to you as a result of this change will not exceed the costs charged to your utility.
