**COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY OF NOTICE**

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and in response to Order No. 3, files this Recommendation on Sufficiency of Notice.

**I. BACKGROUND**

On November 14, 2017, Bethel-Ash Water Supply Corporation (Bethel-Ash) filed a petition to amend Certificate of Convenience and Necessity (CCN) No. 10821, in Henderson County.

On February 20, 2018, Order No. 3 was issued, establishing a deadline of April 2, 2018 for Bethel-Ash to file signed affidavits that notice was given, along with a copy of the notice sent to affected parties and published in a newspaper of general circulation. Order No. 3 also established April 12, 2018 as the deadline for Staff to file a recommendation on the sufficiency of notice. This pleading is therefore timely filed.

**II. SUFFICIENCY OF NOTICE**

Bethel-Ash failed to file the requested documents. Thus, Staff recommends that it be determined that notice was insufficient.

**III. CONCLUSION**

Staff respectfully requests for an order to be entered finding that Bethel-Ash has failed to file the requested documents, and, that, thus, notice is insufficient.




