**CITY OF HUTTO'S PROOF OF NOTICE**

COMES NOW, the City of Hutto (the "City" or "Hutto") in the above referenced preceding and files this Proof of Notice pursuant to Commission Staff's Recommendation on Notice, dated February 21, 2018, and Order No. 2, dated April 2, 2018, and in support thereof, shows the following:

**I. Background**

On February 21, 2018, the Staff of the Public Utility Commission ("Commission") filed a Recommendation on Notice ("Recommendation") requiring Hutto to provide notice of its application to amend its sewer certificate of convenience and necessity ("CCN") to certain neighboring systems, cities, and landowners. Attached to the Recommendation was a memorandum from Gregory Charles in the Commission's Water Utility Regulation Division, which further clarified the steps Hutto must take to provide notice (the "Memorandum"). Order No. 2, issued on April 2, 2018, required Hutto to file proof of notice by April 6, 2018. Therefore, this pleading is timely filed.

**II. Notice**

On March 16, 2018, the City of Hutto provided notice of its CCN application to all entities identified in the Memorandum and Recommendation that were located on the Texas Commission on Environmental Quality's Water District Database. Each notice included a map of the City's

proposed sewer service area and a cover letter explaining that after the City filed its initial CCN amendment application, it had revised the requested service area. The cover letter, the notice, and the map are attached hereto and incorporated herein for all purposes as **Exhibit “A.”** The Affidavit of Notice to Neighboring Utilities, Landowners, and Affected Parties is attached hereto and incorporated herein for all purposes as **Exhibit “B.”** Exhibit “B” further provides the date each notice was sent and the names of each entity notice was provided.

Of the entities listed in the Memorandum and Recommendation, Hutto did not notify San Gabriel MUD 1, Seven Oaks Ranch MUD, and South Fork Ranch MUD<sup>1</sup> because contact information for the entities was not listed within the Texas Commission on Environmental Quality’s Water District Database and Hutto could not find an address, point-of-contact, or an email for the entities. Hutto additionally communicated with Gary Horton, GIS Specialist with the Commission’s Water Utilities Division, regarding San Gabriel and Seven Oaks. Mr. Horton stated that he was also unable to identify anything for these two entities and recommended that Hutto note in its filing that Hutto “made a good faith effort to reach” the entities “but no current contact information was available.” See **Exhibit “C.”**

Hutto additionally published the Notice of Application to Amend a Certificate of Convenience and Necessity for the Provision of Sewer Service in Williamson County, Texas in the Taylor Press newspaper on Sunday, March 18, 2018, and Sunday, March 25, 2018. The Publisher’s Affidavit and tear sheets are attached hereto and incorporated herein for all purposes as **Exhibit “D.”**

The City of Hutto filed an application with the Public Utility Commission of Texas to amend its Certificate of Convenience and Necessity (CCN) No. 20122 for the provision of sewer service in Williamson County.

The requested area is located approximately between 3 and 6.5 miles in all directions from downtown Hutto, Texas, and is generally bounded on the north by University Blvd/Chandler Rd and SH 29; on the east by CR 101 and FM 3349; on the south by US 79, CR 138, and a line approximately 1 mile south of and parallel to CR 132; and on the west by CR 100, CR 110/Hutto Rd, and Dana Dr.

The total area being requested includes approximately 14,306 acres and serves 0 current customers.

**See enclosed map showing the requested area.**

*Persons who wish to intervene in the proceeding or comment upon action sought should contact the Public Utility Commission, P.O. Box 13326, Austin, Texas 78711-3326, or call the Public Utility Commission at (512) 936-7120 or (888) 782-8477. Hearing- and speech-impaired individuals with text telephones (TTY) may contact the commission at (512) 936-7136. The deadline for intervention in the proceeding is (30 days from the mailing or publication of notice, whichever occurs later, unless otherwise provided by the presiding officer). You must send a letter requesting intervention to the commission which is received by that date.*

If a public hearing is requested, the Commission will not issue the CCN and will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. If an evidentiary hearing is held, it will be a legal proceeding similar to a civil trial in state district court.

If you are a landowner with a tract of land at least 25 acres or more, that is partially or wholly located within the proposed service area, you may request to be excluded from the proposed service area (or "opt out") by providing written notice to the Commission within (30) days from the date that notice was provided by the applicant. All requests to opt out of the requested service area must include a large scale map and a metes and bounds description of the tract of land.

If you have already filed an opt out request in this docket, you do not need to refile your request so long as it included everything required by 16 TAC § 24.102(h)(1): (A) the commission docket number and CCN number; (B) the total acreage of the tract of land subject to the landowner's opt-out request; and (C) a metes and bounds survey for the tract of land subject to the landowner's opt-out request, that is sealed or embossed by either a licensed state land surveyor or registered professional land surveyor.



