### SOAH ORDER NO. 4 AMENDED NOTICE OF THE SECOND PREHEARING CONFERENCE

On May 22, 2018, the Administrative Law Judge (ALJ) convened a prehearing conference pursuant to SOAH Order No. 2 to consider pending motions, a procedural schedule, and any other matters that would assist in the disposition of this case. Parties in attendance included the City of Hutto (Hutto) and the Staff of the Public Utility Commission of Texas (Staff). Other individuals in attendance are identified on the attached Exhibit A, which includes individuals who have filed "opt out" requests, motions to intervene, and/or have requested a hearing in the case.

### I. PROOF OF NOTICE

The ALJ finds that Hutto's notice of its application to amend sewer certificate of public convenience and necessity (CCN) No. 20122 (Application) was legally sufficient and that the deadline for filing motions to intervene was thereby established in SOAH Order No. 2 as April 24, 2018.

### II. NOTICE OF SECOND PREHEARING CONFERENCE

The ALJ will convene a **second prehearing conference at 10:00 am**. <u>August 2, 2018</u> at the State Office of Administrative Hearings, William P. Clements State Office Building. 300 West 15th Street, Fourth Floor, Austin. Texas. Those attending the prehearing conference are advised that they must check in with building security personnel in the lobby of the

William P. Clements Building and be issued visitor badges before the proceeding to the hearing. The parties should allow sufficient time for the check-in procedure.

At the prehearing conference, the following matters will be discussed:

- 1. Requests to opt out;
- 2. Requests for a hearing and/or to be named as intervenors;
- 3. A procedural schedule; and
- 4. Any other matters that may assist in the disposition of this case in a fair and efficient manner.

The deadline to file briefs on the question of standing of the submitted intervenor requests is 3:00 p.m. on **June 19, 2018**. Response briefs are due at 3:00 p.m. on **July 3, 2018**. Those requesting to be named as intervenors must appear at the second prehearing conference in person or by representative. Potential intervenors will be provided with an opportunity at the prehearing conference to make a statement in support of being named a party in this case and the ALJ will make a determination regarding who will be granted intervenor status at that time.

#### III. PROCEDURES

- 1. Notice of the second prehearing conference shall be mailed to all persons listed on Exhibit B, which includes all individuals who have filed a request to intervene, a request for hearing or to receive notice of a hearing, and/or a request to opt out.
- 2. All notices to be submitted by parties in this matter may be by electronic means.
- 3. Drafts of proposed testimony shall not be subject to discovery.
