**CITY OF HUTTO'S
AMENDMENT TO THE APPLICATION**

The City of Hutto, Texas (“**Hutto**”) files this Amendment to the Application in the above referenced proceeding and would show the Administrative Law Judge (“**ALJ**”) as follows:

I. Amendment

November 21, 2017, Hutto filed an application with the Public Utility Commission of Texas (the “**Commission**”) to amend its sewer certificate of convenience and necessity, number 20122, in Williamson County, Texas (the “**Application**”). On February 7, 2018, Hutto amended its Application by filing a revised map to modify the area it is requesting be included in its sewer service area (“**Requested Area**”). Hutto now desires to amend its Application a second time by removing additional parcels of land from the Requested Area. The map, attached hereto as Exhibit “A,” depicts the area Hutto is requesting be included in its sewer service area pursuant to the Application. The Requested Area consists of 13,480.17 acres. Exhibit “A” also includes the following: (i) a key that identifies the owners of the tracts of land Hutto has removed from its Requested Area and (ii) a map that provides a closer view of some of the parcels of land Hutto has removed from its Requested Area.

II. Conclusion and Prayer

WHEREFORE, PREMISES considered, for all the foregoing reasons, the City of Hutto respectfully requests that the ALJ accept this Amendment to the Application and Hutto’s newly revised requested service area, as depicted on Exhibit “A.”

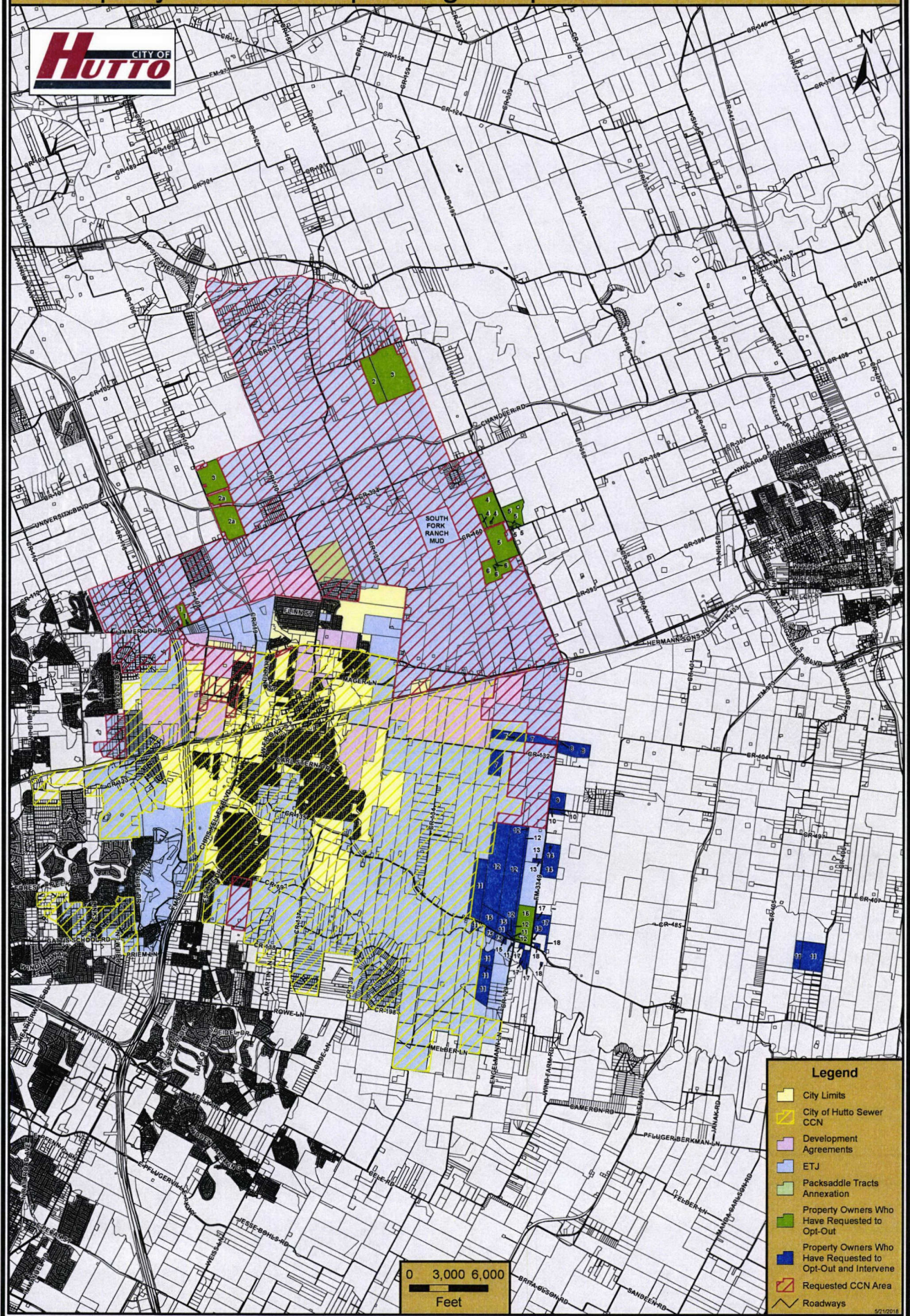
