SOAH ORDER NO 5. REFERRING CASE TO MEDIATION AND RULINGS ON PENDING MATTERS

On August 2, 2018, the Administrative Law Judge (ALJ) convened the second prehearing conference (Second Conference) pursuant to SOAH Order No. 4 to consider pending motions, a procedural schedule, and any other matters that would assist in the disposition of this case. Parties in attendance included the City of Hutto (Hutto) and the Staff of the Public Utility Commission of Texas (Staff). Attorney Patrick Reznik also appeared on behalf of: Dana R. Boehm, DVM, Emzy Boehm, Troy and Jennifer Boehm, Terry Dolan, Cynthia D. Krueger, Wynette Norman Lessner, Raymond and Diane Naivar, and Isaac W. Norman (collectively referred to herein as the Boehm Alliance).

I. RULING ON PENDING FILINGS

On June 15, 2018, Hutto filed its second amendment to its sewer certificate of public convenience and necessity (CCN) No. 20122 application (Amendment). Hutto, the Boehm Alliance and Staff stipulated that all of the property for which various filings have been submitted, including all requests to intervene, all requests for hearing and all applications to "opt out" of the area for which Hutto is seeking to add to its CCN (Proposed Service Area) are now outside of the Proposed Service Area. Accordingly, the ALJ finds that all of the filed "opt-out" requests, which are identified in Table 1, are for land that is now outside the Proposed Service Area and are therefore moot.

II. REFERRAL TO MEDIATION

After reviewing the filings in this proceeding and by agreement of the parties at the Second Hearing, the ALJ determines that this case shall be referred to SOAH's Alternative Dispute Resolution Team Leader, Judge Howard S. Seitzman, for mediation between Staff, Hutto, and the Boehm Alliance. With the issuance of this Order, the official file in this case is referred and transferred to Judge Seitzman to conduct mediation.

Judge Seitzman will be contacting Staff, Hutto, and the Boehm Alliance directly to confirm the proposed mediation date of August 20, 2018, at 9:00 a.m. By August 13, 2018, the Boehm Alliance shall submit to Staff and Hutto a list of documents, issues, and concerns that the Boehm Alliance desires to be discussed during mediation. Once Judge Seitzman confirms the mediation date, all persons are ordered to appear at the mediation with a representative (in addition to the attorney) who has full settlement authority for this matter. The case shall be returned to the ALJ by September 28, 2018, unless extended by order of the presiding ALJ. Furthermore, this case is not abated. Any requests for relief prior to or during the period of mediation should continue to be filed.

III. PROCEDURES

This Order No. 5 shall be mailed to all persons listed on Exhibit "A," which includes all individuals who have filed a request to intervene and/or a request to opt out.
