I regret that it takes an outside force to cause change to occur in systems such as ours. The Hurricane and resulting flooding cut short our petition drive short. Many members of the water system disagreed with the rate hike and poor management but would not sign because of fear of retaliation from the Manager Mr. Todd Fontenot and Board President Mr. Anthony Fontenot (who are brothers).

If more signatures are needed we can get them with more time for the petition. Our main goal is to have a water system that will supply clean drinking water at a reasonable cost. We are also concerned about the original water lines that were installed to service a few homes, but now in many cases are supplying water at low pressure to many connections.

Our system needs to strike a balance between expanding and upgrading the existing poorly designed and maintained lined.

Another problem that disturbed some people is the less than truthful use of a \$5.00 dollar per month for 60 months that was supposed to purchase and install two (2) new generators. The money was collected but the generators were supplied at no cost through a grant. No one was informed of this change, but the money approximately \$150,000 was spent on "other needed maintenance problems". This should have been communicated to the owners of both the money and the Water Supply Corporation!
