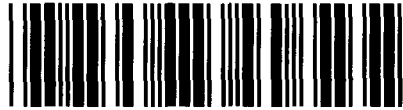

Raywood Water Supply Corporation had 519 ratepayers whose rates have been changed by the rate increase appealed in this case and effective as of June 30, 2017. A copy of the last page of the Raywood Water Supply Meter Reading Upload Report from our handheld meter on June 30, 2017 is provided as proof of documentation. 10 percent of the affected ratepayers (customers) eligible to appeal would therefore be 52 by our records.
