DEFINITIONS

- A. "Raywood WSC", "Company" or "you" refers to Raywood Water Supply Corporation and any person acting or purporting to act on their behalf, including without limitation, attorneys, agents, advisors, investigators, representatives, employees or other persons.
- B.
